

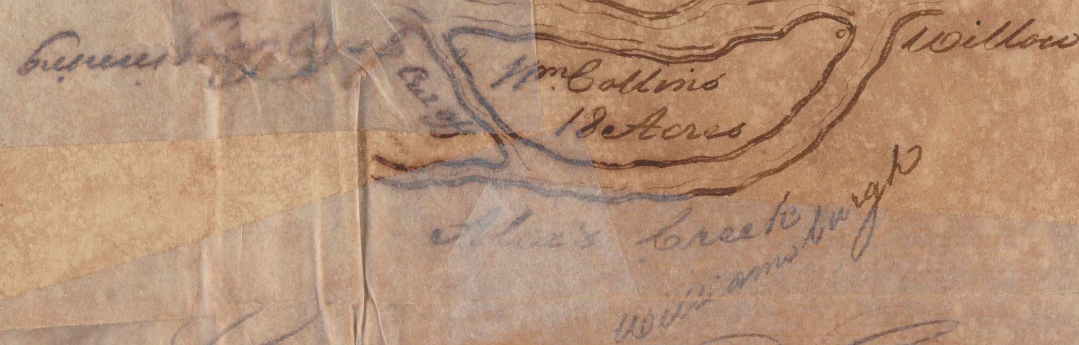

STATE OF GEORGIA.

By his Honor David Emanuel, President of the Senate  
and Commander in Chief of the Army and Navy of this state, and of the Militia thereof.

To all whom these presents shall come, GREETING:

KNOW YE, That in pursuance of the Act for opening the Land Office, and by virtue of the powers in me vested, I HAVE given and granted, and by these presents, in the name and behalf of the said state, DO give and grant unto William Collins his Heirs and Assigns forever, all that Tract or Parcel of Land, containing eighteen acres, contained in an Island called Mud Island ~~is~~ situate, lying and being in the County of Glynn in the said state, and butting and bounding by the Alapamaha, Alex. Creek, and a cutoff

having such shape, form and marks, as appear by a Plat of the same hereunto annexed; together with all and singular the Rights, Members and Appurtenances thereof, whatsoever, to the said Tract or Parcel of Land belong; or in anywise appertaining; and also all the Estate, Right, Title, Interest, Claim and Demand of the state aforesaid, of, in, or out of, the same; TO HAVE and TO HOLD the said Tract or Parcel of Land, and all and singular the Premises aforesaid, with their and every of their Rights, Members and Appurtenances, unto the said William Collins his Heirs and Assigns, to his and their own proper use and behoof forever, in fee simple.
