

I may be entirely mistaken, but I feel that Earnest is spending too much time practicing on the piano. I know that practice makes perfect, and all that, but I do believe that Earnest needs to let up a little and kick up his heels out-of-doors for a time.

Please talk with him, and see if he might be interested in going to our camp for girls near Abingdon, Virginia, next summer. I could use him from June 15 to September 1. He would have time for a reasonable amount of practice, and could play often for the girls at night, but I would also want him to do some manual labor on tennis courts and the like, drive the camp truck to town for provisions, and so on.
