Wing Commander promoted to brigadier general

Moody's Wing Commander received an early birthday present Tuesday morning when his wife, Carol, pinned brigadier general stars on his uniform in a brief ceremony in the general's office.

Brig. Gen. Cecil F. Fox, who will celebrate his birthday Monday, is the first Wing Commander to pin on his stars while still at Moody, making him the first commanding general officer in the history of the Wing. He is the third Wing Commander promoted to the general rank since the base reopened in 1951.

The Waco, Tex., native doesn't anticipate that his promotion will affect Moody's mission. "My major goals are still the same," General Fox commented, "-- to make Moody the best and safest undergraduate pilot training base in ATC." The general is experiencing a personal change, however. "Once you become a general, they don't let you fly with students anymore as an instructor pilot," he said.

General Fox was one of the 73 colonels selected for brigadier general this year. By law, there are only 412 generals in the Air Force.

The 49-year-old general, who assumed command of the 3550th Pilot Training Wing Nov. 12, 1971, expects to be notified of his next assignment within the next few weeks. Before his assignment to Moody, General Fox served as Commander of the Air Force Advisory Team N. 4 at Binh Thuy AB, Republic of Vietnam.

General Fox and his wife, the former Carol Abraham of Collinsville, Ill., have three children: Michael, Teresa and Brian.

Mrs. Isreal Wright of Deerfield, Fla. was the weekend guest of her mother-in-law, Mrs. Alice Harris of Hahira.

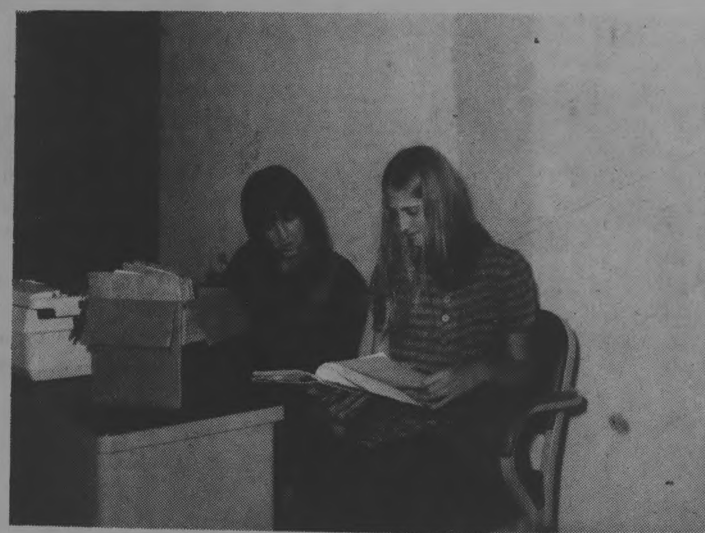

Customer Report #2

"Why is my electric bill higher than my neighbor's? We have about the same size house and number of appliances."

Probably the main reason is that, just as no two individuals are alike, no two families are exactly alike in their habits and ways of living.

Air conditioning can use more electricity than all your appliances put together. Yet, some families insist on a chilly temperature indoors all summer long. Others prefer a moderate thermostat setting, and this could make quite a difference in your electric bill.

It's difficult to estimate how much power your air conditioner may use, because of the many variables involved: size of unit, wattage, climate, length of time used. To give one example, a room-size unit with 1,566 wattage would consume an average of about 1,389 kilowatt-hours annually.

If you're buying an air conditioner, you might want to consider a high-efficiency model. Efficiency is determined by dividing the BTU rating by the watt rating — the higher the resultant number, the more efficient the unit. Extra-high efficiency models will cost more initially, but less to operate.

Air conditioning is largely responsible for the tremendous growth in electric demand, and is the reason for much of our construction. Because of this, electricity costs more from June through October, when you use more than 600 kilowatt-hours a month.

Cut Cooling Bill

You can enjoy air conditioning and help keep costs down if you follow these tips:

1. Set the thermostat at 78 degrees. Each degree lower uses five percent more power.
2. Clean or replace the filters frequently.
3. Keep draperies or curtains drawn on the sunny side of the house. Try thermal draperies, or thermal linings with your present ones.
4. A house without insulation may use up to 50 percent more electricity (or any fuel) for cooling and heating. Six inches is the recom-

mended thickness for ceiling, three for walls and floors. Weatherstrip doors and windows.

There are other ways your family may be using more electric energy than your neighbor. Perhaps you do a lot of cooking, while they bring home fried chicken or pizza. And think about the refrigerator. Each time the door opens, cold air rushes out, causing the unit to run more to replace it. You'll cut down on electric costs if you watch that door.

Or, if you have a frostfree refrigerator and your neighbor doesn't, you'll use 30 to 50 percent more electricity here.

As for small kitchen appliances, such as knives, mixers or coffee makers, it takes very little electricity to operate these. A carving knife, for instance, consumes about eight kilowatt-hours a year in average use; a mixer, about 13. An electric toothbrush will use an average of five. You can see that the increasing demand for electricity isn't based on such appliances. If you enjoy and need them, keep them clean and in good working order.

More Ways to Save

Look at your laundry next. Two families may have the same type equipment, but no two families will have exactly the same amount of laundry. You can save on electricity if you run the washer and dryer only with full loads.

Lights? Television? Hi-fi and radio? Some families keep them on whether they're in use or not. When they're not, turn them off.

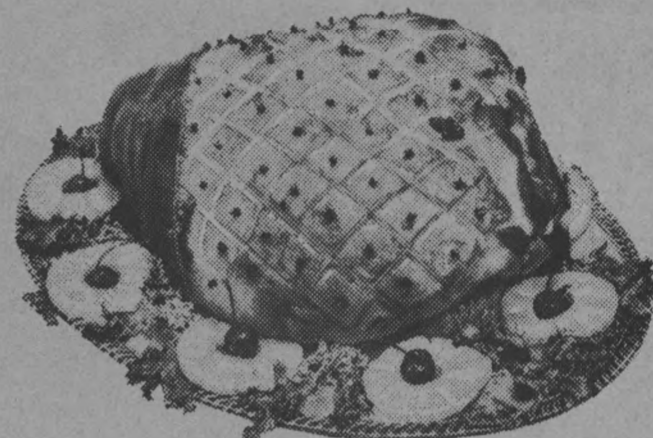

Lowndes meeting change certified

VALDOSTA, Ga. - Lowndes County Commission's new official meeting date has been certified but the commission will also meet on its old date this month in order to hold a previously scheduled zoning hearing.

Thus the regular May meeting of the commission will be held Wednesday morning.

However, the commission had already advertised for a zoning hearing on May 9 which

would have been its first meeting date of the month under the old law. Therefore, the County Commission is calling a special May 9 meeting in order to have the zoning hearing, Mrs. Pendleton said.

After this month the only regularly scheduled meeting of the Lowndes County Commission will be on the first Wednesday of each month. The commission meets at 8 a.m.

From Mrs. Alis F. Whitaker, Pitman, N.J.: I remember when we wore bathing suits made of navy blue wool as thick and heavy as blanket wool. The blouse part had a large sailor collar piped in white braid and puffed sleeves reaching to the elbow and also piped in white braid. The skirt came to well below the knee and had three rows, just below the hem, of white braid. The bloomers, sometimes sewed into the suit at waist level, had elastic in the legs and a narrow ruffle below, which was, of course, piped with white braid. The bloomers were worn sometimes above the knee and sometimes below, depending on the daring of the wearer. These suits, when dripping wet, could weigh ten pounds more or less, and to trudge from water's edge to bath-house was no easy feat. The non-swimmers, which most of us were, had our water-wings, two air-inflated canvas in front and worn across the ribcage with the bubbles floating behind our shoulders, so that if we waded beyond our depth, we wouldn't drown.

Infections reported down

Editor's Note: This is the second of four interviews presenting opinions on whether women have the right to terminate unwanted pregnancies during the first three months.

LOS ANGELES — It is the patient's right to have an abortion within the terms of legality. It is her right alone, and no one else's.

So says Dr. John McNicholas, a gynecologist of suburban Glendale, who is in favor of and has performed abortions.

Dr. McNicholas contends that, in his opinion, "if a woman is desperate enough about having an abortion, she will always find one to do it."

His contention is substantiated by the fact that "before 1967 when the abortion law went into effect, Los Angeles County Hospital used to get large numbers of infected abortions from this area and from below the Mexican border.

"Deaths from abortions were not at all uncommon then," he said.

Since the inception of legal abortions, the number of infected abortions has decreased enormously, according to Dr. McNicholas.

Furthermore, women and girls who had had illegal abortions and had complications such as infection or

hemorrhage as a result often would avoid medical help since "if a girl came in bleeding or with infection from an abortion, a doctor could treat her, but he had to report her as having had an abortion," Dr. McNicholas explained.

If the girl agreed to name the abortionist and testify in court against him, she was given legal immunity, he said.

He pointed out that at Memorial Hospital of Glendale, where he is on staff, "we performed about 18 to 20 abortions a year in 1968-69.

"In the last two years, we have performed more than 100 abortions a year."

What about the supposed guilt feelings that are said to haunt a woman who has had an abortion?

He said that an article by a psychiatrist who interviewed a number of women who had had abortions led the psychiatrist to conclude that stories of guilt feelings were greatly exaggerated.

In fact, Dr. McNicholas knows "of only one patient on whom I performed an abortion who experienced deep depression afterward.

"In retrospect, it turned out she'd been conned into the abortion by her family and by her boyfriend — and he subsequently left her," he said.

The rest of his abortion patients "have been happy with what they have done.

"There are no feelings of

guilt — no recriminations, just relief," he said.

He explained that doctors only will perform abortions during the first three months of pregnancy or between 16 to 20 weeks.

He said that no ethical doctor would perform an abortion after 28 weeks because there is a possibility of viability — the baby can then sustain life on its own and at that point the idea of an assault on a human life becomes an actuality.

Dr. McNicholas explained that after 28 weeks "you treat the mother and her pregnancy to preserve her life and the baby's.

"You do not attack the baby in preference to the mother — you treat the life of both to preserve the life of both," he said.

What about the argument that there are any number of married couples incapable of bearing children who would love to adopt unwanted babies?

"I think it's sad that people cannot have children, but I don't think this gives them the right to use someone else as breeding material," he said.

"I don't think any human being can expect another human being to go through pregnancy — which is a long, drawn-out and possibly dangerous affair — just to provide them with the child which they cannot themselves conceive," he said.

Fonda fares better than Tokyo Rose

Mrs. Iva Toguri D'Aquino must be muttering in her saki these days — if she can afford saki — as she contemplates her own past and Jane Fonda's present.

Mrs. D'Aquino, as all World War II Pacific veterans know, was at that time Tokyo Rose, the gal who thought she was broadcasting Japanese propaganda that would damage our morale. Instead, her jibes came out as hilarious comedy and the music she played topped anything Armed Forces Radio had to offer.

For her trouble — or her heresy — she served two years in jail before conviction for treason, then about seven years of a 10-year sentence at the Alderson, W. Va., federal women's prison.

Miss Fonda, on the other hand, has it much better.

She over many months denounced her own country in its efforts to save South Vietnam from Communist invaders. She visited the enemy on his own ground — North Vietnam — and with her enthusiasm for the foe, she might well be tabbed "Hanoi Hannah." She capped this, to say the least, "unusual" behavior by denouncing the American prisoners of war, just returned from months and years of torture at the hands of their North Vietnam captors. She called our POWs "liars and hypocrites."

For all these deeds, or misdeeds as some see it, she still has an American passport to go anywhere in the world she pleases to denounce the coun-

try her citizenship responsibilities require her to defend and uphold. She has not been arrested and, under the totally permissive system that both our people and our government have come to accept, she is in no danger of arrest. The information industry, particularly the television people, gives her every opportunity to mouth nasties about America and its fighting men — all, I suppose, in the name of freedom of the press.

Such is the difference in public and official attitudes between the 1940s-'50s-'60s and the roaring '70s.

Differences in attitudes notwithstanding, Mrs. D'Aquino, now working in her parents' Chicago produce business, must wonder about standards in U.S. justice and public attitudes.

Rose, and we will call her that because that is how the GIs knew her, was an American citizen (half Japanese) visiting a sick relative in Japan when Pearl Harbor was bombed on Dec. 7, 1941. She was 25 at the time and she was persuaded, compelled or perhaps volunteered to use her seductive voice on Radio Tokyo broadcasts beamed at U.S. soldiers, sailors and airmen fighting across the Pacific.

Whatever her intentions — and they were to damage GI morale — she was the hit of the Pacific. Her favorite line, and I recall many of her broadcasts well, went something like this:

"Pvt. John Horton, Co. B,

EDUCATION

School costs in focus

The U.S. Supreme Court has focused attention on the public schools' most critical problems by rejecting the education establishment's conventional solutions for them.

This is a bonus from the high court's recent ruling disagreeing with the contention that pupils are denied equal protection under the law as guaranteed by the Constitution's 14th Amendment if local school financing is based on the wealth of their school district as represented by property values.

While reversing the U.S. District Court for western Texas in the Rodriguez case, Justice Lewis F. Powell Jr., who wrote the five-member majority opinion, called for a revision of school financing.

The court also showed considerable insight into the problems of measuring school and teacher effectiveness, the goals of education and control of schools.

The court squashed one of the fondest liberal dreams, that a public education is an inalienable constitutional right. "Education, of course, is not among the rights afforded explicit protection under our federal Constitution. Nor do we find any basis for saying it is implicitly so protected."

The crux of the argument for equalizing educational expenditures within a state in Rodriguez and similar rulings in seven other states is that there is a direct relationship between money spent on education, educational quality and the amount of knowledge in a pupil's head.

One of the hottest sources of controversy," the court explains, "concerns the extent to which there is a demonstrable correlation between educational expenditures and the quality of education — an assumed correlation underlying virtually every legal conclusion drawn by the District Court in this case.

"Related to the questioned relationship between cost and quality is the equally unsettled controversy as to the proper goals ... of public education. ... The ultimate wisdom as to these and related problems of education is not likely to be divined for all time even by the scholars who now so earnestly debate the issues."

Justice Powell discusses this issue further in relation to rating teachers. "... The extent to which the quality of education varies with expenditures per pupil is debated inconclusively by the most thoughtful students of public education ... the issues of greatest disagreement include the effect on the quality of education of pupil-teacher ratios and of higher teacher salary schedules.

"But there appears to be little empirical data that supports the advantage of any particular pupil-teacher ratio or that documents the existence of a dependable correlation between the level of public school teachers' salaries and the quality of their classroom instruction. An intractable problem in dealing with teachers' salaries is the absence, up to this time, of satisfactory techniques for judging their ability or performance. Relatively few school systems have merit plans of any kind, with the result that teachers' salaries are usually increased across the board in a way that tends to reward the least deserving on the same basis as the most deserving."

Newsprint Prices Increasing For Second Time This Year

Newsprint producers have begun posting their second round of U.S. price increases this year. The \$5-a-ton hikes are effective July 1. These hikes came from the east and south with no new increases from the west as yet.

The newsprint companies cite rising costs particularly for labor - as a key element prompting the increases, which follow a similar round of \$5-per-ton boosts in February. It seems the vital materials that go into publishing a newspaper have shot up, as has everything else, in recent months and years.

We will continue to absorb all the costs possible, but it goes to say there must ultimately be a rise in subscription rates, in single-wrapped papers and in advertising rates. We hope our patrons will bear with us and realize the pressure we are in today with rising prices on every hand.

ST. JOHN Nader charge rejected

NEW YORK — "Nader's thesis was," observed author Charles McCarty in his book "Citizen Nader," "that General Motors had marketed a car its executives knew to be unsafe, and GM had done for the controlling purpose of making money. This was, of course, very close to an accusation against the corporation of negligent homicide."

This charge was made by Ralph Nader against GM's Corvair back in 1965 in his book, "Unsafe At Any Speed." The Nader book, plus his 1966 appearance before a congressional committee, headed by Sen. Abraham Ribicoff, D-Conn., catapulted Nader into national prominence and made him America's No. 1 "consumer crusader." Although his credibility was based largely on the auto safety issue, he was believable and became almost immune to searching criticism.

Now seven years after those remarkable hearings held by Ribicoff and the airing of charges against GM, Ribicoff has released a report, inserted in the Congressional Record, that politely repudiates Nader's charges against the Corvair and his later assertion that GM officials misled the Ribicoff Staff Investigation Report of the subcommittee on Executive Reorganization states the following:

"For more than two and a half years, we have conducted an extensive investigation into Mr. Ralph Nader's charges that statements of certain General Motors witnesses at the hearings of March 22, 1966, misled the subcommittee on Executive Reorganization concerning the safety of the Corvair automobile. After

consideration of all the relevant evidence, we have concluded that the subcommittee was not misled and hence there is no basis for reopening hearings for further testimony on the stability and handling of the Corvair.

Although we have not upheld Mr. Nader's charges against the Corvair and General Motors, we believe they were made in good faith based on the information available to him. After gathering evidence concerning them, we can understand how he reached the positions stated in his letters. The documents he

cites provide some support for his views. However, we believe the clear preponderance of the evidence, much of what was unavailable to Mr. Nader, is on the other side. Nader has disputed the Ribicoff committee, realizing that his entire career was built on the auto safety issue in general and his case against the Corvair in particular. The documentation provided by the Ribicoff committee runs hundreds of pages of testimony. General Motors, at the time of the 1966 hearings, argued in vain that the Corvair was as safe as any automobile they had produced. Because of the blunders of GM in investigating the background of Nader and an uncritical press preferring to believe Nader rather than GM, the Corvair issue raised

by Nader was forgotten in the character assassination of GM. In fact, the passage of the 1966 Auto Safety Act was due more to the sensationalized aspects of Nader than on an evaluation of the merits of Nader's case against the Corvair and GM. The Senate subcommittee in its March, 1973, staff report makes this remarkable admission: "By every objective measure we have been able to find, the Corvair compares favorably in stability and handling with contemporary compact cars of that era (1960-63)."

708th Amphibian Tank Battalion, don't you wish you were back in Stratford, Conn., enjoying a chocolate sundae at the corner drugstore instead of wallowing in the mud of Saipan? It's a long war — and you may never get to the drugstore again. Most of us obviously wished we were at the corner drugstore, or neighborhood bar, but Rose's voice had the opposite result intended. The likes of "Pvt. Horton" were proud to be mentioned on her program and officers and enlisted men would gather around a radio intended for tactical activity only for laughs when their name might be mentioned. She gave a tough war a light touch, one of the greatest morale boosters of the Pacific. However, at war's end, in the fall of 1945 she was picked up by U.S. military authori-

ties in Tokyo. She was held in infamous Sugamo prison until Oct. 26, 1946, then freed by Gen. of the Army Douglas MacArthur for lack of evidence. This did not end her troubles. Returning to the United States (as an American citizen), she was re-arrested, and tried again for treason in San Francisco. After a 12-week trial and four days of jury deliberations she was convicted of one of eight charges. Foreman John Mann of the jury said the jurors would have liked to acquit her but "We did the only thing we thought possible under the judge's instructions." Her \$10,000 fine and 10-year sentence on the one count was a shock to her and to many others — even though technically she had wronged her country. She said, "I can't understand it. I couldn't believe they would send me to jail. I've already been in jail two years." With that memory in mind, Tokyo Rose can be forgiven if she is bewildered today as she reads about free-wheeling Jane Fonda.

Tips for Homemakers

KNOW THE LANDSCAPE PLANTS

When plants are bought at a nursery be sure to learn about the cultural practices needed to get the growth from the plants. Never buy a shrub without learning how big it grows, color of blooms, evergreen or deciduous in nature, exposure it will grow best in, and rate of growth. This information can be the difference between a successful and disappointing landscape job.

Often the first question asked a nurseryman is - "How fast will it grow?" The money to be spent on plants is usually limited and the buyer is interested in a small plant that will grow fast and make a good show in a short period of time. This will lead to a great deal of pruning in the future years trying to keep the shrubs from covering the windows and crowding other plants.

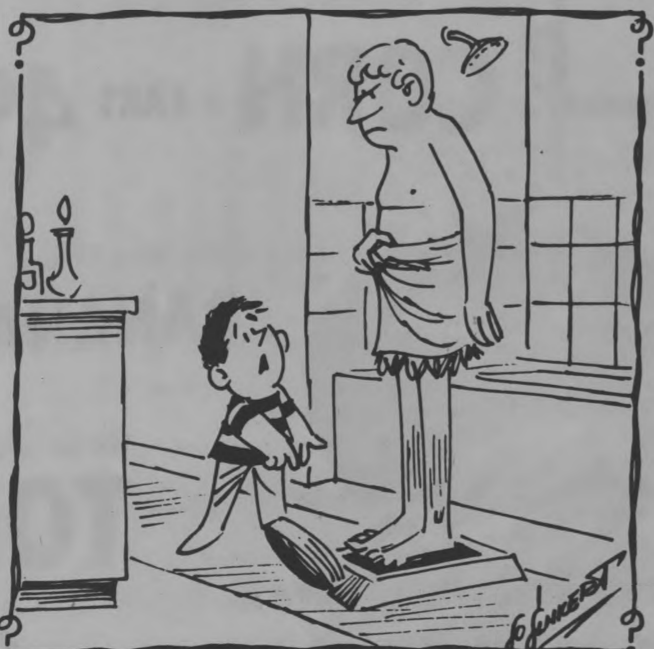
It is better to buy slower growing plants and have a little more patience. Some of the low or dwarf type plants will not grow to the size wanted as fast, but are less trouble when pruning time comes around.

Gumpo Azaleas, Heller Holly, Dwarf Burford Holly, Carissa Holly, Rotunda Holly, Dwarf Yaupon Holly, Blue Rug Juniper, and Andorra Juniper are a few of the low type shrubs that require little pruning.

Tall, fast growing plants, such as Ligustrum, Elaeagnus and Burford Holly are often used as base plants, but will be out of proportion with a low building in a few years if severe pruning is not practiced. Save these plants for the large two-story building or for hedge and screening work.

Mix 2 cups of cooked and drained beans with 2 chopped green peppers, 2 chopped cucumbers, one-half cup grated cheese, half a small onion chopped, one-half cup diced celery and 2 medium tomatoes (sliced). Toss with 3 tablespoons of salad oil, salt and pepper to taste and serve on a lettuce leaf.

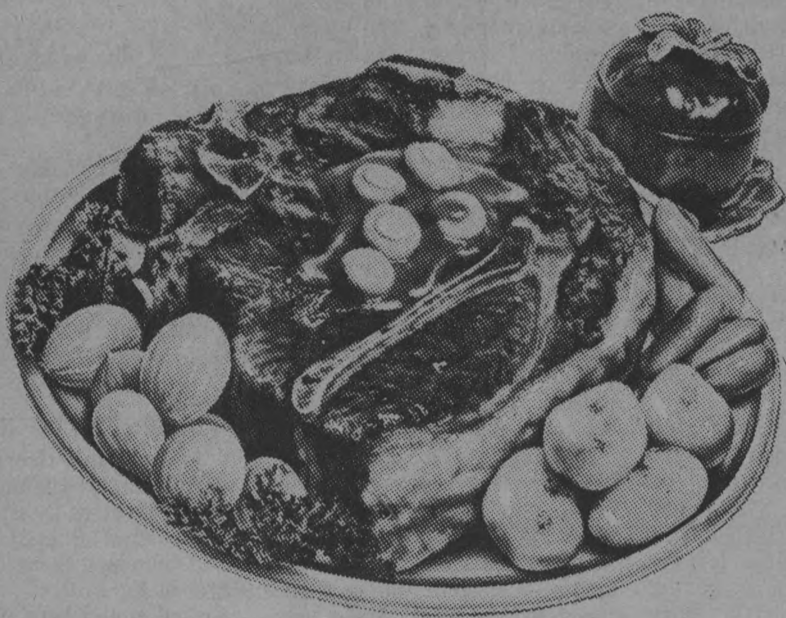

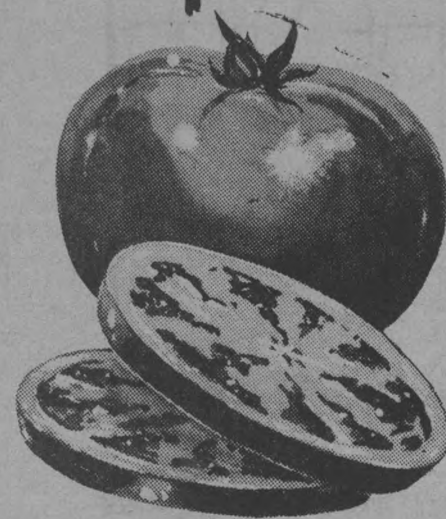

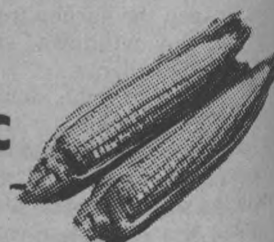
