IF THERE ARE DOUBTS ABOUT THE STEPTOE/EDWARDS IN VITRO FERTILIZATION OF LESLEY BROWN, THEY ARE NOT BEING EXPRESSED HERE. THE BARREN FOUNDATION'S WITHDRAWAL OF AN AWARD TO STEPTOE SEEMS UNFOUNDED, AND FOOLISH, TO U.K. OBSERVERS.

STAFFERS ON THE OLDHAM EVENING CHRONICLE, WHO HAVE BEEN CLOSEST TO THIS STORY, HAVE NO PARTICULAR AFFECTION FOR THE RATHER HAUGHTY STEPTOE, BUT THEY DO NOT DOUBT FOR A SECOND THAT STEPTOE/EDWARDS DID WHAT THEY SAID THEY DID. NOR DOES ANYBODY ELSE WITH INTIMATE KNOWLEDGE OF THE SITUATION. STEPTOE HAS INSISTED ALL ALONG, AND INSISTS NOW, THEY SAY, THAT HE AND EDWARDS HAVE NOT RECEIVED ANY PAYHENT FROM THE PRESS FOR THEIR STORY. STEPTOE IS EN ROUTE TO AUSTRALIA FOR SOME KIND OF ENGAGEMENT CTHEY DON'T KNOW WHAT, OR WHERED. STEPTOE WAS QUOTED IN LONDON PAPERS OCT. 30:

THE BROWN FAMILY WAS, INDEED, PAID BY ASSOCIATED NEWSPAPERS, PROBABLY FAR LESS THAN THE POUNDS 300,000 FIGURE UHICH WAS BANDIED ABOUT. RELIABLE SOURCES THINK IT WAS ABOUT POUNDS 100,000. AND STEPTOE/EDWARDS DIDN'T GET ANY OF IT, THEY SAY, FILES AT THE TIME, WE RECALL, NOTED THAT THE REPORTED POUNDS 300,000 FIGURE WAS UNRELIABLE AND PROBABLY INFLATED.

THE BIG NEWS TODAY, ON PAGE ONE OF THE DAILY MAIL, IS THAT A SECOND TEST-TUBE BABY BY THE STEPTOE/EDWARDS METHOD IS DUE TO BE BORN ABOUT FEB. 14. THIS IMPENDING BIRTH WAS REPORTED EARLIER BY THE OLDHAM EVENING CHRONICLE. THE MOTHER-TO-BE IS A SCOTTISH VOHAN, MRS. GRACE MONTGOMERY, 32. AND SHE HAD SIMILAR TREATMENT AT OLDHAM TO THAT WHICH LESLEY BROWN HAD. IN FACT, FOR A BRIEF TIME SHE OCCUPIED THE BED AT OLDHAM GENERAL WHICH MRS. BROWN HAD OCCUPIED.

MRS. MONTGOMERY HAS NO FALLOPIAN TUBES. IN FEBRUARY, 1977, HRS. MONTGOMERY WAS ONE OF SEVERAL WOMEN AT THE STEPTOE/EDWARDS HOSPITAL WHO HAD EGGS FERTILIZED OUTSIDE THE WOMB AND THEN REPLACED. ALL THE OPERATIONS FAILED. LAST MAY SHE RETURNED TO OLDHAM, AND THIS TIME 21 WOMEN HAD THE OPERATION. ONLY MRS. MONTGOMERY'S WAS SUCCESSFUL. THE DAILY MAIL QUOTES MRS. MONTGOMERY, WHOSE HUSBAND, JIM, IS AN INSURANCE AGENT: "IT WAS HEARTBREAKING WHEN ONE BY ONE THE GIRLS LEFT. I KNEW THIS WAS MY LAST CHANCE BECAUSE I HAD DEVELOPED AMOTHER MEDICAL COMPLICATION. I DECIDED I WAS GOING TO THINK CUNDERLINE THINK) PREGNANT."

AT THE END OF JULY, WITH EVERYTHING GOING WELL, MRS.

MOITGOMERY RETURNED TO WORK AS A COOKERY AND CRAFTS TEACHER. THE

ONLY UPSET SINCE THEN HAS BEEN A CONTRACTION LAST MONTH, THE

NAIL SAID, WHICH FRIGHTENED HER. BUT AFTER A COUPLE OF DAYS IN THE

HOSPITAL, SHE WAS WELL AGAIN. YESTERDAY, LESS THAN 24 HOURS AFTER

SEEING AN ULTRASONIC SCAN OF HER HEALTHY BABY, SHE SAID: "I

FEEL GREAT—BETTER THAN I "VE FELT FOR YEARS." THE MAIL CARRIES A

PAGE ONE PICTURE OF MR. AND MRS. MONTGOMERY. MRS. MONTGOMERY SAYS

SHE WAS TOLD SIX YEARS AGO SHE COULD NEVER HAVE A BABY. THE

DAILY HAIL SAYS THE NEWS OF MRS. MONTGOMERY'S PREGNANCY "CONFIRMS

THAT THE TECHNIQUE DEVELOPED BY STEPTOE/EDWARDS BIS A BREAK-THROUGH WHICH WILL GIVE THOUSANDS OF CHILDLESS WOMEN NEW HOPE.

THE GUARDIAN, REPORTING WITHDRAWAL OF THE AWARD BY THE BARREN FOUNDATION, SAID NOV. 1 EDWARDS SAID STEPTOE AND HE FULLY INTEND TO GIVE THE FULLEST INFORMATION TO THE MEDICAL AND SCIENTIFIC PRESS.

SIR JOHN DEWHURST, PRESIDENT OF THE ROYAL COLLEGE OF OBSTETRICIANS AND GYNAECOLOGISTS, TOLD THE GUARDIAN HE THOUGHT THERE HAD BEEN NO UNDUE DELAY IN PUBLISHING, SINCE THE BABY IND BEEN BORN ONLY THREE MONTHS AGO.

PROF. JOHN DOBBING, PROFESSOR OF CHILD GROWTH AND DEVELOPMENT AT MANCHESTER U., SAID IT NORMALLY TOOK ABOUT SIX MONTHS FOR AN ARTICLE TO APPEAR IN A LEARNED JOURNAL. HE SAID: "I WOULD WORRY IF WE DID NOT GET A PUBLICATION BY THE SUMMER, BUT NOT BEFORE THEN—THAT'S THE TIME IT TAKES." OTHER AUTHORITIES THOUGHT IT COULD TAKE EVEN LONGER.

THE TIMES QUOTED EDWARDS: "I THINK THEY CHARREN FOUNDATIOND ARE ABSOLUTELY FOOLISH." HE SAID A SCIENTIFIC REPORT WOULD BE PUBLISHED "IN THE NEW YEAR. " EDWARDS SAID "WE ARE NOT GOING TO PUBLISH AT OTHER PEOPLE'S BECK AND CALL. IN THE MEDICAL WORLD YOU PUBLISH WHEN YOU ARE READY."

OLDHAM SOURCES DELIEVE STEPTOE/EDWARDS MAY WANT TO WAIT UNTIL AFTER THE SECOND BABY (MRS. MONTGOMERY'S) IS BORN.

A SPOKESMAN FOR THE LANCET SAID IT HAS HAD NO FURTHER COMMUNICATION FROM STEPTOE/EDWARDS SINCE THEIR AUG. 12 LETTER, AND THE LANCET DOESN'T KNOW THEIR PUBLISHING INTENTIONS. THE LANCET HAS NO REASON TO DOUBT STEPTOE/EDWARDS STATEMENTS. THE DELAY BETWEEN RECEIPT AND PUBLICATION OF A MANUSCRIPT CAN BE BETWEEN TWO AND EIGHT WEEKS. IF AN ARTICLE IS URGENT, IT CAN BE

BETUEEN TWO AND EIGHT WEEKS. IF AN ARTICLE IS URGENT, IT CAN BE PUBLISHED WITHIN A FORTNIGHT, THE SPOKESMAN SAID, BUT THIS IS A CONFIDENTIAL MATTER BETWEEN THE AUTHORS AND EDITORS.
