STEPTOE AND MYSELF REGARDING THE BIRTH OF THE FIRST TEST TUBE BABY IN THE LANCET C12TH AUGUST 19782 AND A FURTHER REFERENCE WAS MADE IN THE BRITISH MEDICAL JOURNAL C19TH AUGUST 19782.

"AT THIS PRESENT STAGE OF OUR RESEARCHES, WE FEEL THAT IT WOULD BE PREMATURE TO PUBLISH A PAPER CONCERNING OUR WORK. IN NO OTHER FIELD WOULD IT BE REGARDED AS NORMAL TO PUBLISH FULL DETAILS AFTER THE FIRST SUCCESS.

"I WISH TO EMPHASISE THAT WE HAVE AT ALL TIMES BEEN TOTALLY FREE TO PUBLISH IN MEDICAL AND SCIENTIFIC JOURNALS AND THAT OUR SOLE REASONS FOR NOT DOING SO WERE PROMPTED BY THE NEED TO EVALUATE PAGE 2 LN32

OUR WORK FULLY.

"WE WILL LAY OUR RESULTS BEFORE THE MEDICAL AND SCIENTIFIC COMMUNITIES FOR CRITICAL AND OPEN SCRUTINY AS SOON AS IT IS POSSIBLE HAVING REGARD TO THE REQUIREMENTS OF SCIENTIFIC RESEARCH IN MEDICAL AFFAIRS, ANY SUGGESTIONS TO THE CONTRARY, AND ANY QUESTIONING OF OUR GOOD FAITH AND COMPETENCE ARE DEEPLY RESENTED AND, I AM ADVISED, ACTIONABLE.

"MR. STEPTOE IS ON HIS WAY TO AUSTRALIA, AND I HAVE NOT BEEN ABLE TO CONTACT HIM, BUT I AM SURE HE WOULD AGREE WITH THIS STATEMENT."
