This past year has been remarkable. We accomplished some historical achievements with a cohesive and calm Board of Directors. Church Members should be proud of the Board's ability to make decisions and to work together despite the vast distances which separate Directors.

Seventeen years ago I was working with an attorney to draw up the papers for our incorporation as a church, a legal entity giving us the same rights and protection as are afforded any legal religious institution. One of the Articles of Incorporation is that we share a collective responsibility to provide a place of worship. At this time, there is no 'formal' place. We do not own a collection of buildings so that you can head down to your neighborhood Temple of Lothloriën. In fact, that type of 'mainstream' membership, requiring many thousands of Members, would be the antithesis of our goals. We do share, however, the goal of someday acquiring a parcel of land near the Mothervalley where we could some day hold our Annual Retreats and accomplish other goals we share within Lothloriën.

This past year the Church has taken a major step toward that goal. Your Church is now a property owner, holding title to an acre of stunning real estate. There will be no building erected on this land. And, although there are two ritual sites now in use, it will not be a major gathering place. Yet this sacred land will provide you with the knowledge that, should you wish your athame or other most sacred tools cared for after the demise of your body, there is a worshipful place kept sacred.

It is a large responsibility for a Church so small to take ownership of a parcel of land. It would be highly prized by developers and we have been offered large sums of money to make it available to bulldozers which would kill the trees and smash the Stone Circle which has been kept sacred for more than ten years. Lothloriën teaches us to care for the land, to protect Mother Earth. In today's world, this means working to protect parcels of land against pavement and traffic, to provide a refuge for the trees and herbs, a place where the devas and eldritch may dance without fear of human encroachment. This year your Church has grown in maturity.

Now we look to the future. It will be necessary to draft policies regarding so it is not lost through neglect, abused through a lack of planning. The policies will be created by The College of Mentors and the Board of Directors, but the wishes and desires of our Members are being taken into consideration. We must be pragmatic and realistic yet we must continue our goals of bringing Lothloriën into manifestation. This past summer the Board of Directors, at their Annual Meeting, developed a new mission statement which is now before our Members. We are also seeking to rewrite our brochures and flyers to reflect our growth and changes and to improve the manner by which we present ourselves to the 'outside world.' The web site developed and maintained by Rev. Ron is a major step forward in the ways by which we communicate about ourselves.

Working to craft these policies is a look toward the future. In this process a new edition of A Wiccan Bardo must be brought into print and we look forward to our next major gathering: cabins have been reserved next to Old Faithful in Yellowstone National Park in the year 2000 ce. Coincidentally, that year will also be the twentieth anniversary of our legal recognition as a Church. There will be much cause for celebration and for sharing. All Members and their partners/families are invited to share one of the most powerful sites in North America, a land where the earth makes visible her workings as maiden and mother, where she is continually creating and stirring and showing the pulse of life from within her.

How much can we grow between now and then? The answer lies within you. The Rowan Tree Church is your Church. The Tradition of Lothloriën is open to all who find beauty within its poetry and familiarity and comfort within its beliefs. Yet underlying the poetry is the 'so below,' the actual daily work it takes to make Lothloriën and your Church available to you. The Annual Report represents many hundreds of hours of volunteer labor. My personal contribution averages twenty or more hours a week and I am but one of those who offers time and labor so that your Church continues to function. This Annual Report is a learning device. It can help you better understand just what is The Rowan Tree Church

How did our Church do this past year? Our fiscal performance was not outstanding. On the surface, we lost \$259.52. In large part this deficit occurred due to some one-time expenses within the last two months of our fiscal year. Here is how the different budgets within the Church fared.

**How do we get our money?**

A significant part of our money comes from Member donation. Although it is easy to think of your Church's expenses amounting to little more than the cost of your monthly *Rowan Tree News*, it cost the Church nearly \$9,000.00 to do its business in the 1996-97 fiscal year. Were it not for other sources of income, that amount averages approximately \$15.00 per Member per month. The reality is that Member donations averaged approximately \$5.00 per month.

Member donation totals ran from a high of \$314.81 in March to a low of \$110.00 in September (which caused the General Manager to do some panicky juggling).

The money you donate to the Church is tax exempt. Where does that money go? Five cents of every dollar goes into the Land Fund and the other ninety-five cents goes into the Church's operating budget. Many Members donate money and ask that it go into one of the other budgets. The former editor of *The Littlest Unicorn*, for example, donated the cost of printing the newsletter.

There are many sources of income, however. A detailed list follows:

**Where does the money go?**

That's a good question. Your Church is managed by a very small number of dedicated volunteers. The bookkeeping is a voluntary position requiring about 200 hours a month plus the expense of driving about 250 miles with bank deposits over the course of a year. Editors put in considerably more time. Each Director on the Board is responsible for studying the month's agenda and writing out comments and recommendations, a copy of which is made and sent to every other Director. We have no paid positions and there are no salaries.

Out of our roughly 50 Members, a core group of nine dedicated volunteers managed to publish the *RTNews*, *The Unicorn* and *The Littlest Unicorn*. Thirteen issues of a publication for Mystery School students and twelve published Agendas for the Board of Directors were mailed out as well. Promotional flyers, brochures and a spectacular web site make us accessible to people outside the Church. Mail continues to arrive at the old post office box in Minneapolis where our Minnesota Agent (who represents us for the State of Minnesota where we are incorporated) drives 45 miles round trip once a month to pick up the mail and mail it to us here in Kirkland. Some months there are more than thirty requests for free information. Over the course of a year we send out promotional literature to an average of 300 people. In addition there are several bulk mailings, Member monthly forms and donations receive written encouragement from the Secretary and our core volunteers send out a wealth of written material. We are, after all, a wide-spread web within Lothloriën and rather than spider silk, we spin paper. In addition to the paper used at the home office in Kirkland (which we buy in cases of ten reams at a time) there is considerable printing expense.

There are other expenses as well. The telephone is another of the threads of our communications web. Important Board decisions require the phone line for the fax machine, a cost of nearly \$200.00 per year. The total telephone bill for 1996-97 was \$937.47 which included \$377.39 paid by The Mystery School. Other expenses included such things as the \$492.30 for the rental of a portable toilet (and its weekly servicing) which is essential at The Hermit's Grove. (The other half of that expense is paid for by the Beyerls and the Grove.)

We made a donation of \$12.00 to the Northwest AIDS Foundation in the Church's name. We pay \$20.00 a month to the Minnesota Agent, without which we would have to start from scratch to once again receive our tax-exempt status with the IRS. Using an agent is the standard practice with most non-profit and for-profit organizations paying an attorney fees averaging more than a hundred dollars each month. Not only is ours a bargain, but she drives over 500 miles each year to pick up our mail and pays for shipping it here out of her modest stipend.

The Church also rents a storage locker where records, archives and other materials are stored. This costs \$40.00 each month. A more recent (but now permanent expense) is the approximately \$20.00 per month for the web site. Here are our expenses in detail:

You voted for the Board and hopefully you read the news of Board activities in the *RTNews*. Despite our occasional requests for Member involvement, we assume you are happy with the way we make decisions and spend your money, because we get no letters of complaint (nor of encouragement) and no one has asked to join the Board as an observer in order to watch us more closely. Who are the current Directors?

#### Vice President, Board of Directors

This past year there was much on the plate of the Board of Directors. And, rather than reporting our actual accomplishments (which have appeared regularly in the *RTNews*) I would like to comment on the present functioning of the Board.

I have been involved with the BOD now for somewhere in the area of 4 to 5 years if memory serves, and I cannot think of a time when we have functioned so well as a group. Given that for each of us life can and sometimes does get the better half of our attention, we have nonetheless made a great deal of change and forward growth. We are coming into a time of maturity for our Church and our Tradition. Within the Mystery School, we can often times clearly see areas that need to be refined; now this is becoming a reality for our Membership and all around us we can see growth. Obviously changes within the Mystery School are brought about by the College of Mentors, but within the greater Circles of the Church change is brought about by the Board of Directors. For some time now the Board has been looking to the Church's Membership for their comments and concerns about all of the events that do require discussion. Issues concerning the use of the land in Kirkland to redesigning the Welcome Packet Materials are all critical issues for the regular functioning of our Church. As the Board looks to you, the Membership of the Rowan Tree Church, know that we need to make these changes with you, in order that changes we make serve our Membership as best we are able. I invite all of you be a part of this process as we continue to care for and nourish the Rowan Tree - together.

Working with the Scribe of the Church, i helped in the voting on amending the Book of Legislation last Spring and on the voting for the Board of Directors this fall.

If there are any ways in which i may serve you, PLEASE let me know. i look forward to the coming year. i also look forward to the Yellowstone Retreat in the year 2000. i hope to meet many of you there!

### Fund Raising Committee Annual Report

Ritual herbe packets were offered to the Membership. The herbes were bought in bulk from the Hermit's Grove and packaged in individual use portions for the Wheel of the Year celebrations. These herbe collections will be available until the end of 1997.

Rowan Tree logo T-shirts were well received. The new colors of burgundy and teal received compliments. Although we ordered some of all the sizes offered by the printer, we did have requests for an extended size range in the future. Thanks for the feedback.

I want to thank all of you for your support. This is one of the ways we manifest our fantasies into reality.

### Periodicals

#### The Unicorn

With the Hallows issue, *The Unicorn* is in a year long celebration of its twentieth anniversary. As part of this observance, a contest was run with free subscriptions and actual cash prizes (although very modest!). Voting on the best short story, poem or artwork are the subscribers, using an 'Olympic' type scale ranging to 10.0. For years we've had a stable

subscriber base and the number of paid subscribers is exactly the same as last year. For each non-renewal we have a new subscriber.

With an abundance of fiction, articles, letters, poetry and artwork, *The Unicorn* is a showcase for the creative talent within our Church. Andrius' opening letter and the ongoing tales of "The Hatchling" keep the modern myths of Lothloriën alive. Significant events within the Church are echoed in the saga of Dark Star and her two hermits, Arnica and Holly. When two Directors came to The Hermit's Grove from Denver this past summer, threads were woven into the story of "The Hatchling." *The Unicorn* is a reflection of The Rowan Tree Church and of Lothloriën, although the casual reader who is not a Member would never notice.

How did *The Unicorn* begin? Initially, Rev. Paul wanted to start up a mail order herbal service. It was named *The Unicorn*, in honor of a glass unicorn he received from a friend having told the friend of the unicorn in "The Glass Menagerie," a play by Tennessee Williams. The first "issue" of *The Unicorn* was a price list of herbs with a couple of paragraphs. This was followed three months later by a fairly chatty mailing which was soon called a "newsletter" by a couple of the very few other publications/groups in existence: Circle Farm (as it was then known) in Wisconsin and Castle Rising (now defunct) in Colorado. That word brought into manifestation one of Rev. Paul's dreams which had been around since he was in the second grade, asking for a "printing press" which had been advertised. A childhood dream was to publish some type of neighborhood newspaper. The kit turned out to be a woodblock with small, unwieldy rubber letters and a pair of tweezers. But *The Unicorn* turned out to be the only publication in North America which is still going twenty years later. One or two have older roots but were interrupted. *Green Egg* spent many years out of publication.

Where did Andrius come from? Originally a literary device, Andrius was chatty, known to be fond of chocolate chip cookies and maidens, and a source of light-hearted humor combined with a knowledge of the Mysteries. Although initially a creation of Rev. Paul, Andrius began taking on a life of his own through the faith and belief of the readers. There are many stories which demonstrate Andrius' reality as an astral unicorn. One of our favorites is when a young girl, Michelle Weed daughter of a then staff artist, was taken seriously ill. A long distance call from a panicked mother told Rev. Paul that the doctors were uncertain if Michelle would survive the next couple of days. I knew that Michelle adored Andrius and to her young wonderment, he was as real as anything. Karen, her mother, wanted Rev. Paul to perform a healing ritual. Instead, knowing Michelle's affinity for Andrius, Rev. Paul recommended that Karen tell Michelle to "dream of Andrius" that night. Michelle did dream of Andrius and had a near-miraculous recovery, sent home from the hospital in less than two days.

*The Unicorn* is one of the most visible aspects of our Church to the rest of the pagan world and has its own budget. At one time a major player among pagan newsletters, the current trend toward slick pagan magazines and newspaper formats has left *The Unicorn* as a role model for the newsletter format having its own niche.

Your goal, as Church Members, should be to give serious

thought to *The Unicorn's* future. After twenty years with Rev. Paul it's doubtful that he'll be editing it for another twenty. It's time to begin thinking about developing the plan and training so that *The Unicorn* can survive its founder. Would you want it to continue publication after its editor is no longer available? With our Membership scattered over such a distance, a contingency plan is not easily derived and your thoughts and creative solutions would be useful.

## The Mystery School of Lothloriën

### Eldermentor

This past year Lothloriën celebrated the Initiation of two new Priests. As we begin our new year, two Church Members have been accepted into The Mystery School of The Rowan Tree Church. With the Dedication of a Novice we know as Dreamweaver, we now have openings for new Novice Supplicants.

The Mystery School now functions with a majority of those within it as Initiates. This offers us a depth to our work and the ability to utilize the Magick which embodies Lothloriën. There have been no significant changes in the Pathworking. Rather, we who are within the Inner Circle of The Mystery School have grown in our collective understanding of our goals. This past year we studied together the working of The Ritual for the Dead, enhancing our own understanding of the Mysteries of Death and Dying which are integral to our daily ministry to our Members and communities. Our goals for the coming year include furthering our abilities to work together, to

build the energy available through the astral temples and to prepare ourselves for the future of Lothloriën.

The Mystery School expenses are covered by tuition and through the publishing program which includes the spiral-bound ritual books, and the purchase of other books sold through the Library. Out of all tuition, 5% is allocated to the Land Fund, 25% to the Subscription Library, 45% covers Mystery School operating expenses and the Mentor receives 25% to cover a small portion of her/his expenses.

If you have any questions about or interest in The Mystery School, please do not hesitate to contact me. I am more than willing to help you prepare yourself for admission to our training. It is, in many ways, like studying at home for a college degree.

## The Bardmaster

For the most part, what I have to say has to do with my own work towards finishing the Bardic Aspect. I had hoped last year to finish everything for Second Degree/Third Ordeal by this time. In actuality, I finished far sooner, giving the Lothloriën aspect to the College of Mentors and a full generic version to all Board Members. This happened fairly early in 1997, and I still would be grateful for any thoughts or comments from Board Members.

So, I am ahead of my own expectations, being well under way with the Third Degree/Fourth Ordeal. I trust to have this finished about this time next year. I have written many accompanying essays to further explain various aspects of this work which have now begun to appear in the RTNews. I would like to find myself in the position of finishing the Third Degree even sooner so that I may truly spend time examining the beginning (First Ordeal) again. Much has changed and the First no longer totally reflects those changes.

I have been teaching generic students with the intent that they would show me how well my system works. I am pleased to say that not only have they done well, but they have given a wealth of information that shall lead to the needed changes for the Tradition. They have speeded me up and prompted the outflow of essays. I am hopeful that these discoveries shall be positively reflected in how Lothloriën students may be taught. Though I do currently have a Bardic Student, these issues have been difficult to gauge and work on as many questions have required the closer physical connections to resolve. Hopefully, as I said, these aspects will filter over without difficulties. I would like to see all systems work well. One has to understand that it was an important question to me to make certain the system truly works. The Initiation aspect for Bards is powerful and bonding. But at present, it is generic. I want for this to become a Lothloriën experience as well.

With many hopes that this gives a reasonable idea of where the process is,

The Mystery School includes not only the educational program, but other functions within the Church as well. The libraries are assets of The Mystery School and through the library, copies of books written by the founder, Rev. Paul, are sold as well as texts available for purchase by students at The Hermit's Grove.

Several years ago an ambitious publishing program was undertaken by The Mystery School. The printing and spiral binding of rituals and educational books by The Mystery School provide additional income for our work. To give you an idea of the scope of the publishing program, here are the financial figures for the past fiscal year.

In addition to the cost of publishing the spiral bound books (printing), office supplies (paper, binding materials and equipment) are expenses from The Mystery School's operating budget. The price of each book includes a modest royalty to the author and money automatically allocated to the Land Fund. This past year the donation to the Land Fund was \$59.00 Total royalties paid this past year were \$172.00.

The remaining money goes directly into The Mystery School (from spiral-bound books) and The Subscription Library (from works published outside the Church). Monies which were allocated to The Mystery School are indicated in the complete Mystery School budget.

## The Land Fund

Yes, the Church now has some 'land,' but it is not a parcel of property adequate for holding Annual Retreats or other larger functions. One of our original goals which remains part of our incorporated structure is that some day we are to acquire a parcel of land within an hours' drive from the Mississippi, which is known in Lothloriën as the Mothervalley.

For fifteen years we have set aside money for the Land Fund. We sell copies of The Holy Books of the Devas - the original paper edition, although Member interest in this fund-raising option needs renewal. 5% of all tuition paid to The Mystery School by students goes directly to the Land Fund. A secondary source of income is derived from the spiral-bound books published by The Mystery School, those books of ritual and magick which enable Members to learn more about The Tradition of Lothloriën.

In addition sales tax money is kept in the Land Fund, a money market account, somewhat as escrow money to help increase the amount of earned interest in a small way. The same is done with ten dollars from every t-shirt sold so that new shirts can be purchased.

Unfortunately, over the years the Land Fund has been tapped when the need arises, financing the shipping of the Subscription Library from Minnesota to Washington, for example. Today the Board of Directors works hard to avoid using any of this money. An expense of \$250.00 was incurred for the appraisal of the acre of land acquired as a gift from the Beyerls. The Board approved this expenditure as owning a parcel of desirable real estate will, some day, make it much easier for the Church to acquire its Mothervalley parcel.

Last year the balance in the land fund account was \$1850.47. To this we added nearly \$60.00 in interest. When combined with money from The Mystery School (\$136.74 from tuition and \$71.00 from book sales) and with the modest \$32.23 from Members; and expenses of \$250.00 for the appraisal, \$75.00 in attorney fees to draw up the new will, the balance in the money market account is now \$1,861.44 which includes a small sum of sales tax money due the State of Washington at the end of 1997.

This year the Land Fund had significant expense, but was part of the process by which your Church became the holder of a wonderful parcel of sacred land.



## Librarian, Subscription Library

This has been a quiet year for the Subscription Library. Through purchases funded by The Mystery School and money generated by the sale of books and through donations of books from our Members, from The Hermit's Grove and from *The Unicorn*, ninety-eight new and used books were added to the library. A catalog of titles and authors was published at the beginning of this year and is available for those Members who wish to purchase a copy. If you would like a copy, a special offer is one for \$5.00 to cover printing and postage (it's many pages long!).

The library includes not only the outstanding collection of books available to Members, but also the tape library which offers a collection of educational tapes and tapes which allow Members to further their education in our Tradition of Lothloriën and in Wicca. The least known facet of the library is the Periodical Library, which is the storage of twenty years of modern pagan history chronicled in publications gathered through exchange programs and by subscription. Due to their fragile condition they are not available for study but one of the Board's dreams is that some day this resource might be preserved either on microfiche or on CD Rom. The Periodical Library began the year with only \$5.27 in its budget but in addition to its usual sources of revenue, the generosity of two Members has helped it finish the year with a more healthy figure. Expenses for the Periodical Library include printing and postage for those copies of *The Unicorn* which are exchanged for the periodicals added to our collection.
