1. Michael Holt welcomed new members to the committee and began scheduling of future meetings.
2. By-law edits were discussed, updated, corrected, and voted for approval (attached). A major provision is to reduce the number of faculty representatives from two per college to one per college.
3. A master list of technology needs for VSU Information Technology (IT) strategic planning was discussed. The technology committee is charged with reporting back to their colleges, departments, and divisions in request of lists of software and hardware commonly used or needed. Lists from each college will be merged and submitted to VSU IT. The process for making requests for this information was discussed and the committee will work with IT Ex Officio members to establish a university wide method for the master list data collection within the academic year.
4. A subcommittee to address “promoting and improving online learning” was discussed and formed. This subcommittee will communicate with colleges regarding e-learning and bring recommendations back to the Technology committee for consideration.
5. Shawn Merdinger (Chief Information Security Officer & Ex Officio) discussed the need for informing students and faculty/staff or thereby engaging them in “IT Security issues” through information sharing ideas across campus. A subcommittee was formed for further discussion and ideas into the next academic year.
