THIS INDENTURE, made the ninth day of March, in the year of our Lord One Thousand Eight Hundred and seventy-seven, between Isabel Adams,

of the County of Camden, of the other part: WITNESSETH, that the said Isabel Adams,

for and in consideration of the sum of Twenty Dollars in hand paid, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, hath granted, bargained, sold, aliened, conveyed and confirmed, and by these presents doth grant, bargain, sell, alien, convey and confirm unto the said Asa Stafford, his

heirs and assigns, two undivided third parts of all that tract or parcel of land, situate, lying, and being in said County of Camden, State of Georgia, and being a part of the Crow Harbor Tract, known as the Gum-lin Hammock Tract, containing one hundred acres, more or less, bounded on the east by the Lampadocia Tract, on the south by the marsh of the Crow Harbor Tract, on the west by the Hardee and Millaly Tracts of Land, and on the north by land now or formerly belonging to Nathaniel B. Stafford, said lands lying on the north side of the Great Satilla River, in said State and County.
