lying and being in the County of  
Camden and State aforesaid on South  
River, originally granted to James  
Findley in Seventeen hundred and Eighty  
six or seven for Eight hundred acres  
known as, Campadocia, Also one other  
tract of land, in Camden County State  
of Georgia near the above tract granted



to Cabras Wilson in Eighteen hundred  
and fifty three for Five hundred Eighty  
and one half Aers, bounded by J. Hol-  
gendorf and J. Wilson. In Case and  
To hold said tract or parcels of land  
to him the said Sidney Hargraves  
his heirs and assigns to gether with  
all and singular the right memb-  
ers and appurtenances thereof, to  
the same in any manner, belonging  
to his and their own proper use benefit  
and behoof, for ever in full simple,  
And the said John M. Pison for him-  
self his heirs executors and admin-  
istrators the said bargained premises  
to the said Sidney Hargraves his  
heirs and assigns will warrant  
and forever defend the right and  
title thereof against themselves and  
against the claim of all other persons
