writ Now be it Known that the said Henry Wood Sheriff as aforesaid by Virtue of the said writ of fieri facias after giving due legal and public Notice of the sale in three or more public places in the said County did set up and expose to sale All That Tract or parcel of Land containing Two hundred acres Situate lying and being in the County of Glynn butting and bounding on all sides by Vacant Land for which the said James Wood at the said sale became the Highest bidder and purchaser whereof the same was Knocked off to him Now This Indenture Witnesseth that the said Henry Wood Sheriff as aforesaid for and in Consideration of the sum of Two pounds Ten Shillings Sterling being the highest bid that could be Obtained for the premises to him in hand paid by the said James Wood at and before the sealing and delivery of these presents the receipt whereof is hereby Acknowledged towards satisfaction of the Judgment Hath granted Bargained and sold aliened and confirmed and by these presents by Virtue of the writ of fieri facias and the laws of the land Doth grant Bargained sell alien and confirm to the said James Wood his Heirs and Assigns forever All That the aforesaid Tract or Tenement of Land and Premises Together with all and Singular the Houses out Houses Edifices barns Yards Stables ways waters hereditaments sites members and Appurtenances to the same belonging and in possession and reversions remainder and remainders rents issues and profits thereof And all the estate right title interest claim and demand whatsoever in law or equity of the said William Peacock Junr of in and to the same To have and to hold the said Tract of Land and premises with the rites members and Appurtenances thereto belonging unto the said James Wood his Heirs and Assigns To the Only proper use and behoof of the said James Wood his Heirs and Assigns forever In Witness whereof I the said Henry Wood Sheriff as aforesaid have hereunto set my hand and seal the day and year first above Written
