and confirmed, & by these presents doth grant, bargain, sell, alien, convey and confirm, unto the said Peter
Williams his ~~heirs and assigns~~ ALL THAT tract,
or parcel of land situate by, and lying in the County Wayne and State aforesaid
having thet shapes and boundaries as follows to wit Beginning on a Lightwood State and
running South four degrees West one hundred chains to a Lightwood State thence South
Eighty Six degrees East one hundred chains to a Lightwood State thence North four degrees
East one hundred chains to a Lightwood State thence North Eighty Six degrees West one
hundred chains to the beginning. Bounded Southwardly by ~~J C~~ ^{John C} Smith's Land Eastwardly
by ~~by~~ John F. Black's land Northwardly by H P Humphrey's land Westwardly by James Ball's
land. Containing one thousand acres and granted to ^{this said} William B. Sneed on the third of November
