Minutes of April 21, 2005

The Valdosta State University Faculty Senate meeting convened at 3:30 p.m. in the Magnolia Room, University Center.

R. Zaccari discussed the following items:

- December graduates from the College of Nursing had a 100% pass rate on the NCLEX exam.
- The Board of Regents recently voted for a 5% increase in tuition. This is an increase of \$58 per semester for VSU students. This will be a \$1.2 million increase in VSU's annual budget. The media has questioned why tuition is being increased when the legislature has increased funds. R. Zaccari provided some reference points on this subject. The Southern Regional Education Board (SREB) ranked sixteen southern states based on the amount of their annual tuition and fees. In 2001-02 Georgia's public four-year institutions ranked 13th among the 16 states with a total of \$2,478 while Maryland ranked 1st with a total of \$4,504; in 2002-03 Georgia moved to 14th place with a total of \$2,576 even though there had been a 6% increase at the flagship level and a 4% increase at the state level; in 2003-04 Georgia moved to 15th place with a total of \$2,784 even though there had been a 15% increase at the flagship level and a 10% increase at the state level; and in 2004-05 Georgia moved to 16th place with a total of \$2,923 even though there had been a 5% increase. During this same period South Carolina ranked 1st with a total of \$6,126. On a national level, Georgia's flagship universities ranked 35th among the 50 states from 2001-02 through 2003-04 with totals of \$3,418, \$3,616 and \$4,078 respectively. In 2004-05 Georgia ranked 39th with a total of \$4,272 while Pennsylvania ranked 1st with a total of \$10,856. Additionally, Georgia's state universities ranked 39th among the 50 states from 2001-02 through 2003-04 with totals of \$2,480, \$2,605 and \$2,848 respectively. In 2004-05 Georgia ranked 41st at the state level with a total of \$3,019 while New Jersey ranked 1st with a total of \$7,875. These numbers reflect the fact that Georgia's tuition and fees are well below the national and southern region averages. Institutions within the state of Georgia still provide the best bargains in American higher education.

- The VSU Enrollment Management Council recently met with R. Zaccari. This group is looking at graduation rates and retention rates across the University System and the nation. The Enrollment Management Council has set a goal to move the six-year graduation rate at VSU from its' current position of 38% to 45% by the year 2010.
- Chancellor Meredith has just initiated a new theme of student success, which encourages institutions to develop a stronger relationship with students. A number of tracts will be developed to assist students when they have an academic problem. It is imperative that every employee be involved in this initiative of student success.
- There is a new admission pilot project in Georgia. Some two-year colleges and state universities will study a change in admission standards which does not require an SAT or ACT score. However, a high school GPA of 2.0 with a college-prep diploma will be required. The reason for the pilot is to encourage high school students to select post-secondary education after graduation. Georgia currently has one of the lowest percentages of participation in the nation. As a regional university, VSU will not participate in the study.
- The Board of Regents approved the transfer of property located south of the Centennial residence halls from the Foundation to VSU. Construction will begin in the near future at this site on two intramural softball fields, two flag football fields, a multi-purpose field and outdoor volleyball areas.
- The Board of Regents approved the acceptance of a gift from the Scitrek Corporation in the amount of \$300,000. All intellectual properties associated with the Scitrek brand will be transferred to VSU. On May 2, Brian Gerber, Assistant Dean for the College of Education, and R. Zaccari will meet with Department of Education officials in Washington, D.C. to ask for additional funding to move this project forward. The Scitrek project will form the beginning of a teacher training center for science and mathematics.
- The current Student Union is well below the accepted square footage as compared with VSU's peer institutions. The Board of Regents approved a new fee for students that will be designated for the new student union. The old gym and swimming pool will be demolished to make room for 120,000 square feet of new construction. The pre-planning phase of this project will begin immediately; however, it will be some time before construction begins.

R. Zaccari turned the meeting over to M. Meacham. M. Meacham read the list of proxies.

A question was raised regarding the complimentary text book issue. L. Levy addressed the Senate on this issue. He informed the Senate that Laverne Gaskins, University Attorney, has been in discussions with a group specifically charged to review the issue. At this point, they can find no legal authority to state that textbooks become the property of faculty. However, this item is not yet resolved and continues to be reviewed. L. Levy thanked Tommye Miller, Director of the University Bookstore, for her efforts to set up a system through the VSU bookstore which would allow individuals to donate books to help the Tsunami relief efforts.

- e. Report from the Faculty Grievance Committee – Mike Savoie

The Faculty Grievance Committee voted last year to destroy records after the statute of limitations had expired. M. Savoie informed the Senate that all expired records have, indeed, been destroyed. He also informed that Senate that there has been a change in the Record Retention Policy in the Faculty Handbook. It originally stated that records should be retained for one year in a secure off-campus site. It now states that records should be retained for three years in a secure off-campus site. This is in accordance with the Board of Regents' policy.

L. Bell requested the Technology Committee consider increased technology support for professors. M. Meacham remanded this issue to the Technology Committee.

March 23, 2005

Meeting was called to order at 2:35 pm.

The IPC met for the fifth time in the academic year 2004-2005.

At the meeting, Michael Noll gave a brief summary of the Executive Committee meeting held on March 3, 2005. Items discussed included:

- The need to establish and follow clear procedures at VSU in regard to initiatives that eventually become policy after they have been discussed and voted on in the respective committees and on the floor of the Senate (e.g. the inclusion of “sexual orientation” in the non-discriminatory clause of VSU’s Equal Opportunity Statement)
- Update on the question of the sale of complimentary textbooks by faculty
- The question of whether or not full-time VSU faculty are able to teach part-time elsewhere

Next, Marsha Krotseng reported on the UPAC meeting held on March 18, 2005. Topics covered included:

- Dr. Krotseng’s current visit to Murray State University to inquire about possible strategies to help increase the graduation rate at VSU. Within only six years (from 1997 until 2004) the graduation rate at Murray State University increased from 39% to 56%.

In comparison, the graduation rate at VSU in 2004 was 38%. Among other things, Murray State University seemed to have boosted its graduation rates by invoking a culture of “excellence” across its campus and by its commitment to students’ success through an elaborate “web of support.”

Finally, Michael Noll reported on the meeting of the Strategic Communication Task Force from March 16, 2005, and presented to the members of the IPC the envisioned survey on “Communication and Communication Structures at VSU” for discussion.

Following this discussion, the survey is currently being revised. It is envisioned that the survey will be tested during Maymester to make any final revisions if necessary. The survey will then be administered in the Fall Semester of 2005, shortly after the end of the add/drop period. Following a thorough analysis of the survey, a list of recommendations will be presented by the end of the Fall Semester.

Meeting adjourned at 4:00 p.m.

Educational Policies Committee Report
2004 – 2005

The Educational Policies Committee dealt with two items this semester – VSU faculty members enrolling in VSU doctoral programs and unexcused absences for the Regent's Exam.

The first, **VSU faculty members enrolling in VSU doctoral programs** was resolved as follows.

At the September 16, 2004 Faculty Senate meeting the following proposal was adopted:

No full time faculty member of Valdosta State University will be awarded a doctoral degree by the college in which he/she teaches.

Any exception to this policy must be reviewed by the full time faculty members within the department, Department Head, Graduate Program Coordinator, Dean of the College, Dean of the Graduate School, and approved by the Vice President for Academic Affairs. Faculty already accepted into, and currently enrolled in a doctoral program in which they are teaching, are exempt from this policy.

Any proposed exception to the above policy must adhere to the following protocol: A request for an exception will be prepared by the candidate and transmitted to the Vice President for Academic Affairs. The VPAA will send copies of the request to the Graduate Program Coordinator, Department Head, Dean of the College, and Graduate Dean. The VPAA will charge the Graduate Program Coordinator to schedule and chair a meeting of all full-time faculty within the department. The merits of the petition will be discussed and a secret ballot taken to record the vote count. The Program Coordinator is required to draft a synopsis of the meeting and document the vote count. Copies of the report will be sent to the Department Head, Dean of the College, Graduate Dean, and VPAA. The Department Head will transmit his/her recommendation to the Dean of the College. The Dean of the College will transmit his/her recommendation to the Dean of the Graduate School. The Dean of the Graduate School will transmit his/her recommendation to the VPAA. The VPAA will review all reports/recommendations and render a final decision.

This policy will be effective immediately, upon approval by the Faculty Senate.

The second, **unexcused absences for the Regent's Exam**, was discussed within the committee. This issue was raised by a faculty member who was concerned that a colleague reported his son, a VSU student, was penalized for missing class to take the Regent's exam. This occurred several years ago. The committee determined that, although taking the Regent's exam is not an excused absence in VSU or system policy, Regent's exam times are now published in the semester course catalog enabling a student to sign up for a period when he/she does not have a class conflict, students may change their scheduled exam time up to the week of the exam, and

students may also reschedule their exam for the next semester provided they will not have exceeded the credit limit. It was the opinion of the committee (and the requesting faculty member) that no new policy be created and the matter be dropped.

ENVIRONMENTAL ISSUES COMMITTEE REPORT 2004 - 2005

The Environmental Issues Committee has been very busy and productive during this academic year. We held monthly meetings each second Thursday during which numerous topics were discussed, policies were adopted, and subcommittees presented reports on their activities. Their final reports for 2004-2005 are included in this account and follow.

- *Campus Beautification and Stewardship [referred to in this report as the CBS] chair: Brad Bergstrom.*

1. *Members of CBS* participated in the One-mile Branch Ecological Restoration Project Steering Committee, which completed a \$350,000 grant proposal for US EPA funds distributed by GA EPD. Using Whitehead Beautification funds and in-kind contributions from VSU, City of Valdosta, and South Georgia RDC the proposal was submitted in May 2004. Grant denied in September 2004.
2. *May 2004:* Met with Marsha Krotseng, Chief Planning Officer, and Rob Evans (IPG) about Open-space issues in the VSU Master Plan.
3. *From May-August 2004* the CBS, according to its prescribed responsibilities demanded by the VSU Tree Preservation and Maintenance Policy (TPMP), consulted, met with, and corresponded with members of VSU administration on planned development of northern part of Sunset Park area for new dormitory, associated parking, and storm water retention area. The CBS advised on mitigating tree losses, avoiding impacts to near wetlands, and suggested potential use of native plants for project re-landscaping. (Note: advice on latter two issues largely ignored by contractors). CBS chair signed MOA in May based on these multi-party agreements. To accommodate late design changes to the storm water retention pond for the Sunset Park development, at the request of Dr. Zaccari, the acting chair signed a separate, revised MOA in July. At this time, representatives of CBS prepared a report and list of plant species in the affected area, including size data (DBH) of all trees. CBS arranged for visit by US Army Corps of Engineers inspector to educate project principals on avoiding future wetlands impacts.
4. *Summer/Fall 2004:* consulted with Asst. Director of Plant Operations Monty Griffin on several cases of dead, moribund, or diseased/damaged trees on main campus and elsewhere (cf. TPMP Sections III/IV).
5. *August 26, 2004:* CBS members and Monty Griffin met with Dr. Kim Coder, UGA Extension Service urban forestry expert, and made an extensive tour of main campus. Dr. Coder advised on proper care, diagnosis and maintenance of campus trees, particularly the old growth longleaf pines. CBS members raised alarms about destructive excavation practices by private companies working on fiber optic lines in the old-growth grove near the north end of Blazer Blvd. They alerted VSU administrators due to contractors ignoring VSU campus tree protection policy.
6. *Fall 2004-late winter 2005:* CBS consulted with Vice President of Student Affairs and Director of Campus Recreation on development of playing fields on remainder of Sunset Park area. Numerous site visits, tree survey/identification, plan review, and meetings by CBS members with said administrators and project architects from IPG. Results were improved re-planting plan, enhanced diversity of natives and ecological function, and more appropriate mitigation for pre-existing trees lost to development.

7. *November/December*: CBS prepared a draft of proposal for Wayne R. Faircloth Outdoor Classroom and Greenway Project, in the wooded area along One-mile Branch west of the Sustella Ave. parking lot.
8. *November 2004-March 2005*: CBS investigated feasibility of campus-wide wetlands delineation and contacted potential project consultant.
9. *January 2005*: CBS favorably reported to EIC a proposed resolution to reconcile certain sections of the 2004 Master Plan with VSU's TPMP and more clearly delineate areas on campus for special consideration of protection of trees and green space. EIC passed the resolution and sent it to the Senate Executive Committee.
10. *February 2005*: Based on the November dinner meeting and administrators' and Senate Executive Committee suggestions, CBS amended wording in sections of the TPMP to explicitly indicate which members of the administration would be primarily responsible for consulting with CBS on particular aspects of the TPMP. Amendments were passed by EIC and sent to Senate Executive Committee.
11. *March 2005*: CBS approved plans for tree removals, transplanting, and protection associated with an expanded parking lot near Admissions/Auxiliary Services (cf TPMP Section VI).
12. *April 2005*: CBS began consulting with project architects through Monty Griffin on potential plant list for landscaping of proposed pedestrian mall project.

- *Recycling Subcommittee: Chair: Diane Holliman*

The Recycling subcommittee maintained monthly meetings during which they concentrated on recycling campus needs in offices, living residences, and cafeterias. Interest in this subcommittee was extensive with representation from the SGA, Project Learning Tree, students, housing, the library, dining services, VSU safety, Physical plant, staff, faculty, the local Sierra Club, and The Langdale Company.

1. The subcommittee studied issues of what is being recycled by the city—card board, cans, plastics, newspapers, glass, paper, what the city will take and the person power at VSU to collect the waste.
2. \$2,000.00 have been allocated by Campus Safety to purchase several collection bins for plastic and paper refuse and to carry out a pilot project of recycling in the new dorm. They hope to get clear recycling bins and to extend this project to other public and heavily trafficked areas on campus to increase awareness and support for recycling.
3. The subcommittee is planning a study of other campuses, such as Kennesaw, that have successful recycling programs in order to assist the EIC in the creation of a program for VSU.
4. In conjunction with the SGA, this subcommittee is writing a proposal that requires that recycling activities become mandatory for the official recognition of all on campus student organizations.
5. Discussion is ongoing regarding a pickup schedule and the assignment of recycling personnel. Bubba Nolan will do an inventory of all dorms to determine needs for Coca Cola recycling bins.
6. In August 2005 the subcommittee plans to submit a proposal to the EIC for the creation of a VSU Recycling Strategic Plan to coordinate recycling activities between the city of Valdosta, VSU, and the individual academic, student and other units on campus. The realization is that dollars and time will have to be allocated for a successful VSU recycling program.
7. The members are currently discussing and planning sessions to inform and educate everyone at VSU about the need to recycle. Bubba Nolan is the contact person for anyone who requires recycling pickups in their building, office, or department.

- *Energy Conservation Chair: Eneida Pugh*

1. The Energy subcommittee, concerned about the unnecessary consumption of energy used on the tennis courts during evening hours, wrote a letter to Herb Reinhard requesting that specific playing hours be posted and observed. The letter was approved by the EIC and was sent to Executive Committee for action.
2. This subcommittee has requested that a campus survey be carried out by a professional lighting consultant to determine proper positioning, repositioning, and installation of all campus lighting, both current and future.
3. An "Energy Conservation" email campaign began in April 2005 encouraging everyone at VSU to turn off all computers when not in use and lights when rooms are unoccupied. The monetary savings and the reduction in air pollution annually are astronomical. The campaign will be ongoing as a permanent activity of the Energy Subcommittee.
4. IT has been asked to submit to the EIC a report of the total number of computers on campus for the preparation of a Consumption Report fact sheet that will detail a cost analysis for reported computers. The completed report will be passed on to the EIC for review, discussion, and the creation of a policy to be sent to the Executive Committee for approval by the Faculty Senate.
5. A special request has been submitted to Jim Muzzey asking for the custodial personnel to turn off all lights after cleaning rooms in all buildings. In conjunction with this request, Bubba Nolan has been consulted regarding the installation of automatic switches in all buildings to turn off lights during non-occupancy. Both Mr. Muzzey and Mr. Nolan have responded favorably to these requests.
6. In fall, the Chairwoman accompanied Jim Black and spoke to the SGA to discuss the senators' lighting concerns. After the meeting she completed a walk-about on campus with Senator Lawton and Corporal Nealon to inspect lighting needs and to discuss improvement.

- *Parking Usage Subcommittee Chair: Sudhir Goel- no report*

EIC Activities:

- During the October meeting Dr. Marsha Krotseng recapped the Master Plan process that was accepted by the BOR in May, 2004. The participation of the EIC was recognized by Dr. Krotseng, specifically in the One-Mile Branch Stream Restoration Proposal mentioned in the CBS report.
- Bob DeLong, Director of Campus Safety, and his assistant Meredith Lancaster, have worked closely throughout the year with the EIC to educate us regarding their creation of and implementation of safety plans, programs, and environmental health issues. The EIC thanks them for their strong support and cooperation.
- Committee members met with Dr. Zaccari and the Faculty Senate Executive Committee for a discussion/meeting dinner on November 8, 2004 to clarify operational policies as they regard the Master Plan. Nineteen discussion topics and seven Action Steps were the outcome of the meeting that provide a modus operandi for the EIC and the Faculty Senate Executive Committee. The EIC has revisited the Action Steps for compliance and completion by both parties and will inform Faculty Senate Executive Committee of measures taken on our behalf.
- All members of the EIC would like to express our gratitude to Barbara Boler of Langdale Company who donated 750 pine saplings to initiate Earth Day. Planting occurred at Valdosta High School March 10, 2005 by the students of and under the supervision of Mr.

Alvarez. SGA senators Jeremy Baker and Travis Smith were instrumental in assisting in the completion of this project.

- The EIC initiated an Earth Day program March 21, 2005 to educate the students, faculty, and staff regarding ways to protect the environment. The EIC has received invaluable help from the SGA Senators Travis Smith and Jeremy Baker who presented the video “Affluenza” as an educational tool.
- WEB SITE: In December Amelia Harmon of IT created a web site for EIC on which all pertinent information regarding the committee is provided. The information includes Bylaws, the Outdoor Lighting and Tree Preservation and Maintenance policies, Goals, all subcommittees, a member list, and meeting minutes. The web address is <http://www.valdosta.edu/eic/> . All senators are encouraged to visit our page.

The Library Affairs Committee

The library committee met twice this year.

At the first meeting in the fall, Dr. Gaumont reviewed the formula for library allocations and informed the committee of potential reductions in the 2004-05 budget. The committee also discussed the potential for a rise in serials costs that would impact departmental allocations. In addition to library allocations and budget, the committee discussed enhancements to the Galileo-GIL interlibrary loan system, the increased hours of the Internet Café, and the potential for increased hours for the entire library.

At the spring meeting, Dr. Gaumont reviewed the latest information on the library budget, and shared that the anticipated rise in serials costs will be less than anticipated. The committee reviewed two proposals for contingency funds and voted in favor of awarding additional funds to the Departments of Art and Music. At the request of Dr. Gaumont, the committee agreed as last year to allocate contingency funds to the College of Nursing to balance a deficit in their budget line. (In an update two weeks after the meeting, the Nursing budget was balanced due to reduced serials costs.) We also discussed some possible enhancements for our contingency funds application process. The committee also has been informed about progress toward an online ordering system for department library liaisons that may in the future replace the current order card and choice card system. This meeting convened with plans to meet the next academic year, or as needed for additional business.
