#### A. College of Arts and Sciences

Charles L. Hudson Acting Registrar I want to propose a change to our final exam schedule. We now have only 3 days devoted to final exams during the fall and spring semesters. When we first went to the semester system, we had 4 days of finals, and many universities have 5 days of final exams. Limiting final exams to only 3 days has created 2 problems: (1) Exams last until 11:30 p.m., which is very late. (2) They are 7 or 8 exams per day, which increases the likelihood that a student will have 3 or more final exams on the same day.

I propose that final exams begin on "Dead Day afternoon." Final exams could then end at 9:15 p.m., a much more reasonable time, on Wednesday - Friday. They would end at 10:45 on Tuesday, but the latest exam that day would be taken by a 9:30 p.m. class. There are few classes at that time, and students in those classes are used to meeting late during the semester.

For illustration purposes, here is a sample schedule. The important features are not when specific finals are offered but that there are 3 1/2 days of finals with earlier end times in the evening. At 2:00 or 4:15 on Tuesdays, for example, day classes for the times when there appear to be the fewest number of sections could be used.
