"The committees, in their respective jurisdictions, are empowered by the Statutes of the University and the Bylaws of the Senate to:

- a. formulate and recommend policies and procedures governing the administration of the University for approval by the Senate;
- b. be available to consult with and advise the President of the University;
- c. study and make recommendations on matters assigned to them by the President of the University or the Senate; and

d. act as a liaison between the Senate and the administrative officers of the University."

- 9. All Senators: Please remember the requirements for Senators to attend the seven (7) Senate meetings during 2010-11 as stated in the *Bylaws of Faculty Senate* http://www.valdosta.edu/facsen/documents/bylaws2008.pdf
  - Section 2: "Elected Faculty Senate members are expected to attend all Faculty Senate meetings. Two (2) absences by a member of the Faculty Senate from Senate meetings within one (1) academic year shall automatically remove the member from the Senate.

A member of the Faculty Senate who duly designates a proxy for a Senate meeting shall not be counted as absent if the proxy is in attendance at the meeting. Faculty senators must attend a minimum of four meetings per year.

Faculty senators on a leave of absence beyond one semester will be removed from their position.

Section 8: Proxies will be allowed for Senators who are unable to attend Faculty Senate meetings and will be given only to another Senator. Proxies must register with the Executive Secretary prior to the meeting. No person may represent more than one (1) other Senator at a meeting. [Note: if a proxy is needed, it is the responsibility of the senator to find a proxy; it is not the responsibility of either the Senate Executive Secretary or Lisa Copeland in the VPAA's office to find a proxy for a senator who has to miss a Senate meeting.]

## 4. Old Business

a. At its November 19, 2009 meeting, the Senate remanded to the Educational Policies Committee a proposal from Dr. Sheri Gravett for reconsideration of VSU's "30 year rule" for undergraduate courses.

b. At its November 19, 2009 meeting, the Senate remanded to the Educational Policies Committee a proposal from Dr. Richard Carter regarding whether VSU should return to an official "Advising Week" prior to the start of pre-registration or whether an "Advising Month" makes more sense for departments with Designated Advisors.

c. At its November 19, 2009 meeting, the Senate remanded to the Faculty Affairs Committee a Possible Revision to the Faculty Evaluation Model's Appendix C

<u>http://www.valdosta.edu/academic/documents/FEMfinal.pdf</u> by renaming the Annual Faculty Activity Report and Action Plan (AFARAP) Section B. PROFESSIONALGROWTH AND PRODUCTIVITY to include the word "scholarship" because currently the word appears only once in Section B of the AFARAP.

d. At its April 15, 2010 meeting, the Senate extensively discussed a proposed policy from the Faculty Affairs Committee on guidelines for promotion from Lecturer to Senior Lecturer for insertion in the *VSU Faculty Handbook*. A motion was passed to send the proposed policy back to the Faculty Affairs Committee to work with the President and the Provost to further clarify issues relating to Instructors, Lecturers, and the proposed policy on Senior Lecturers.

e. At its May 20, 2010 meeting, the Senate remanded to the Educational Policies Committee a proposal from the Athletics Committee regarding a university-wide policy on make-up assignments.

### HOW THE VSU SENATE WORKS

The Senate serves as the mechanism for <u>shared governance</u> at Valdosta State University (*Statutes*: Chapter 4, Article I -- <u>http://www.valdosta.edu/legal/statutes.shtml</u>).

What the Senate does is to <u>formulate</u> university policy. This is an extremely important function, central to the vitality of VSU. In the words of the *Statutes*, the Senate functions as the <u>representative</u>, <u>deliberative</u>, <u>advisory</u>, <u>and</u> <u>legislative body</u> of the <u>General Faculty</u>.

It includes 56 elected faculty senators (voting), 14 *ex officio* administrator senators (voting), staff participants (non-voting), and student participants (non-voting).

Any faculty member, administrator, staff member, or student can submit an issue for Senate consideration. It must be submitted in writing to the <u>Executive Secretary</u>. [Currently, B.J. Rickman, <u>bjrickma@valdosta.edu</u>], who brings it to the Executive Committee of the Senate. It is strongly recommended that anyone raising an item for the Executive Committee make their report thorough and well-researched. The Executive Secretary is <u>not</u> expected to do any supplemental research or work on your report or item.

The <u>Executive Committee</u> serves as a traffic cop, deciding whether an issue goes to the Senate, and if so, which committee is the appropriate committee to consider an issue.

There are three (3) kinds of Senate committees: statutory committees, standing committees, and special committees. Membership on all committees is either by election or by recommendation of the Committee on Committees to the Senate and the President for approval.

The five (5) <u>statutory</u> committees are permanently established by the *Statutes*. They are major committees - Academic Committee, Committee on Committees, Faculty Affairs Committee, Institutional Planning Committee, and Faculty Grievance Committee. Their chairs, the President, and the Executive Secretary form the Executive Committee.

<u>Standing</u> committees are formed by the Senate, renewable for three-year periods. They are listed in the *Bylaws of the Faculty Senate* <u>http://www.valdosta.edu/facsen/documents/bylaws2008.pdf</u>. Standing committees may form subcommittees. Special committees are formed by the Senate, normally for one year.

Senate committees can <u>initiate</u> policy recommendations within their committee. Senate committees do <u>not</u> have to wait for items to be submitted to them by the Executive Committee. (*Statutes*: Chapter 4, Article VI, Section 3).

Committees make <u>recommendations</u> to the full Senate. The Senate then considers the matter (time limit: 30 minutes). It may accept the recommendation, amend it, or remand the matter back to the appropriate committee. If the Senate adopts a recommendation, the Executive Secretary (w/in 10 working days) sends it to the President, who has 60 days to either approve or disapprove the recommendation, or to seek an extension from the Senate. If approved by the President, the recommendation becomes <u>university policy</u>. If disapproved by the President, the recommendation is returned to the Senate for possible override (requires 2/3 vote) and submission to the General Faculty for its recommendation to the President. The President has the final authority.

<u>Academic Scheduling and Procedures Committee</u>: to review and recommend policies and procedures pertinent to the University calendar, class scheduling, final examination scheduling, University catalogs and bulletins, Honors Day, and commencement.

<u>Academic Honors and Scholarship Committee</u>: to review and recommend collegewide scholarships and honors for students and to arrange for appropriate presentations, including Honors' Day.

<u>Athletic Committee</u>: to review and recommend policies and procedures pertinent to the University programs of intercollegiate and intramural athletics.

<u>Educational Policies Committee</u>: to review and recommend policies and procedures pertinent to advising, undergraduate admissions and retention, public services, and registration; and to hear undergraduate petitions for exceptions to academic policy, including graduation.

<u>Environmental Issues Committee</u>: to review and recommend policies and procedures pertinent to environmental issues, as they relate to recycling, facilities use, campus beautification, and traffic planning.

<u>Faculty Development and Research Committee</u>: to review and recommend policies and procedures pertinent to both graduate and undergraduate faculty development, research, and the use of animal and human research subjects; to receive and review research and development proposals; and to allocate research and development funds.

<u>Library Affairs Committee</u>: to review and recommend policies and procedures pertinent to the Odum Library and its use, and to review and make recommendations related to library allocations.

<u>Minority and Diversity Issues Committee</u>: to review and recommend policies and procedures pertinent to ethnic, religious, and gender minorities; and to review and recommend policies and procedures pertinent to quality support programs for students with special needs including, but not limited to, those with physical impairments, behavior disorders, and learning disabilities.

<u>Student Activities Committee</u>: to review and recommend policies and procedures pertinent to such student activities as student discipline, student publications, student organizations, fraternities and sororities, and concerts and lectures

<u>Student Services Committee</u>: to review and recommend policies and procedures pertinent to such student services as financial aid, housing, health services, counseling services, mail services, and food services.

<u>Technology Committee</u>: to develop and review policies and procedures relating to technology issues and to interface with other statutory and standing committees when such issues overlap their charge.

<u>Academic Committee:</u> a) approves, disapproves, or remands to the originating unit any proposals and recommended changes related to the educational philosophy, academic mission, and educational enterprise of the University;

b) approves, disapproves, or remands to the originating unit any recommended curricular proposals; and c) approves, disapproves, or remands to the originating unit any proposals and recommended changes in the policies and procedures pertaining to the academic programs of the University.

<u>Committee on Committees:</u> a) nominates for Senate approval the membership for all existing statutory and standing committees of the Senate, unless such membership is elected by the General Faculty or Senate; the method for selecting nominees is set forth in the Senate Bylaws; b) oversees election of members to the Senate; c) oversees election of members to statutory committees; d) advises on appointments for membership on University-wide special committees; and; e) fills any vacancy in a statutory, standing, or special committee during the academic year. A replacement must be from the same unit as the person being replaced.

<u>Faculty Affairs Committee:</u> a) reviews policies and makes recommendations pertaining to faculty welfare matters; b) reviews policies and makes recommendations pertaining to the teaching, learning, and research environment of the University; and c) reviews policies and makes recommendations pertaining to general University matters affecting the educational mission.

<u>Institutional Planning Committee:</u> a) reviews policies and makes recommendations pertaining to the operations of the academic and administrative bodies of the University; b) reviews policies and makes recommendations pertaining to academic and administrative effectiveness of the University and its units; c) reviews policies and makes recommendations pertaining to the use of physical, financial, and human resources of the University; and d) reviews policies and makes recommendations pertaining to comprehensive institutional planning.

<u>Faculty Grievance Committee:</u> 1) The Faculty Grievance Committee has the authority to conduct inquires into grievances by faculty who have exhausted the University's appellate channels from the department, to the college, school or division, to the Vice President for Academic Affairs; to attempt the resolution of those grievances by mediation; and to present to the President its recommendations for appropriate response to the grievances it has considered. 2) The Faculty Grievance Committee will not consider grievances involving promotion, salary, non-renewal of contracts, or tenure unless the aggrieved faculty member reasonably alleges violation of University Statutes, academic freedom, administrative processes or procedures, or discrimination on the basis of sex, race, religion, national origin, handicap, or age.
