PROCEEDINGS OF THE UNION ASSOCIATION

SATURDAY, OCTOBER 14, 1922

The sixty-seventh annual session of the Union Association was held with New Hope Church, Berrien County, Ga., October 15, 15 and 16, 1922.

The introductory sermon was preached by Elder E. R. Rhoden of the Ochlocknee Association. Text: "And Jacob fled into the country of Syria, and Israel served for a wife, and for a wife he kept sheep. And by a prophet the Lord brought Israel out of Egypt, and by a prophet was he preserved." Text found in the book of the Prophet Hosea.

Twenty minutes intermission.

The delegates from the churches oof the Union assembled in the house and were called to order by Elder W. H. Tomlinson, our beloved moderator, Elder I. A. Wetherington, being detained at home because of sickness.

Prayer by Elder J. W. McMillan of the Union.

On motion Elder W. H. Tomlinson was chosen temporary Moderator.

The Moderator called for correspondence from the sister churches of the Association. The correspondence was full, except one church.

On motion Elder W. H. Tomlinson was elected Moderator and W. G. Avera re-elected Clerk, by acclamation.

On motion agreed to the same order of business as heretofore.

I. Read the Decorum.

II. The Moderator invited visiting ministers and brethren of our faith and order to seats with us, to aid us in our deliberations and to share with us our joys and sorrows.

III. Called for petitionary letters. Received a statement from Wayfare Church, Coffee County, by Brethren Jesse McKinnon and Lyman Adams asking for admission into the Union, which on motion was unanimously and gladly granted.

IV. The Moderator appointed committees as follows:

First. On Preaching and Finance—Brethren J. I. Hancock, J. A. Weaver and A. H. Guthrie, with messengers of this church.

Second. On Business—Elder Aaron A. Knight and Brethren O. L. Folsom and H. L. Lovett, with Moderator and Clerk.

Third. On Memorials—Elders J. L. Harris, J. W. Mc-Millan and Brother L. L. Register.

Fourth. To Write Corresponding Letter—Brother J. D. Register.

On motion the Moderator called for correspondence from our sister associations with whom we correspond.

Although the weather was inclement and the rain continuous during the forenoon, a small congregation assembled for divine worship. The Elders appointed by the committee preached in the power and demonstration of the Gospel to the comfort, edification and consolation of the attentive audience, and to the glory and honor of the God of Israel, and of His Son, Jesus Christ.

MONDAY, OCTOBER 16TH

The Associatioon met according to adjournment.

II. The Moderator renewed the invitation to ministers and brethren to seats with us as before.

III. The messengers and visitors from the sister associations were received by the Moderator giving them the right hand of fellowship.

REPORT OF THE MEMORIAL COMMITTEE

We, your Committee on Memorials, beg leave to make the following report: It has pleased the good Lord in His kind providence and by His great power to call from our midst Brother W. W. Johnson, who was Deacon and Clerk of -Bethel Church at the time of his death. Brother Johnson was born April the 15th, 1855, and united with Bethel Church, Echols County, Georgia, March 14, 1903. He was ordained to the office of deacon November 19, 1904. Brother Johnson was a consistent, member and a faithful deacon and clerk and was ever found earnestly contending for the faith of the church and the order of God's house until the time of his death, which occurred at his home, May 14, 1922. In his death we realize a great loss to his family, to Bethel Church, to his community and to the Union Association. We deeply regret and mourn his death, but desire to be submissive to the will of God, who doeth all things well. Mt. Nebo Church is situated one-half mile from Mayo Junction and two miles east of Day, on the L. O. P. and G. R. R.

Lebanon Church is situated five miles west of Arabi on the G. S. & F. R. R. and five east of Marshal on the Albany Northern R. R.

COVENANT

We, the churches composing this Association, in love to God, for His glory, and for the promotion of His Cause and Kingdom, in love to one another, having fellowship for each other, in Christian bonds, to live together in associate capacity, as true worshipers of God, and in view of the same do hereby adopt the following:

1. This Association shall be composed of members chosen by the different churches in our union, and duly sent to represent them in the Association, who shall be members whom they judge to be best qualified for that purpose and upon producing letters from their respective churches they shall be entitled to seats.

2. The members thus chosen and convened shall be denominated the Union Association.

3. In the letters from the different churches of the Association shall be expressed their members in full fellowship, those baptized, received by letter, restored, recantation, confession of faith, dismissed by letter, excommunicated, and dead since the last Association.

4. The Association shall have no power to lord it over God's heritage, nor by which she can infringe upon the internal rights of the churches.

5. This Association shall have a Moderator and Clerk, who shall be chosen annually by the members present (who shall be members of the body) and who shall hold their offices until next election.

6. If any new church or churches desire to be admitted into the Union they shall petition by letter and messenger, and upon examination, if found orthodox and orderly, shall be received by the Association, and manifested by the Moderator giving its messengers the right hand of fellowship.

7. We advise the churches not to send more than two messengers until they shall exceed one hundred members, then a messenger for every fifty after the first hundred.

8. It is the object of this Association to promote the general union of the churches.

9. This Association will recognize the gospel discipline of the churches, and drop from our list any church or churches from which sister churches have withdrawn.

10. The minutes of the Association shall be read and signed by the Moderator and Clerk before the Association adjourns.

11. Amendments may be made to this form of government by two-thirds of the members present.

12. Any member knowingly and willingly breaking any of these rules shall be reproved by the Association if they think proper.

13. The Association shall be opened and closed with prayer.

DECORUM

1. Every motion made and seconded shall command the attention of the Association, unless it be withdrawn by the member who made it.

2. Every member who speaks in debate shall rise from his seat and address the Moderator, and shall not be interrupted while speaking except he depart from the subject.

3. No member shall speak more than three times on the same subject without leave of the Association.

4. No member of the Association shall have the liberty of laughing or whispering while one is speaking, nor cast any reflections on the speaker. The speaker shall adhere strictly to the subject and in no wise reflect upon the person who spoke before him, by making remarks on his imperfections, but shall fairly state the case and matter as he can, so as to give his light or idea.

5. No member shall absent himself from the Association without leave.

6. The several names of the members of the Association shall be enrolled by the Clerk and called as often as the Association may require.

7. The Moderator shall be entitled to the same privilege of speaking as another member, provided the chair be filled, and shall have no vote, unless the Association be equally divided.

8. It shall be the duty of the Clerk to keep a record of the proceedings of the Association.

9. To correspond with other Associations of our faith and order.

10. The brethren in the ministry, together with visiting brethren from our sister associations, shall be invited to seats with the Association.

11. The Association shall have the power to adjourn

themselves at any time and place they may think most convenient to churches and the Union.

ABSTRACTS AND PRINCIPLES

Held by the Primitive Baptists in General to the Confessions of Faith.

1. We believe in one true and living God, and that there are three in the God Head, the Father, the Son and the Holy Ghost.

2. We believe the Scriptures of the Old and New Testaments are the written word of God, and the only rule of faith and practice.

3. We believe in the doctrine of eternal and particular election.

. 4. We believe in the doctrine of original sin.

5. We believe in man's impotency to recover himself from the state he is in by his own free will and ability.

6. We believe that sinners are justified in the sight of God by the imputed righteousness of Christ only.

7. We believe that God's elect shall be called, regenerated, and sanctified by the Holy Ghost without the aid of the gospel or the efforts of auxiliaries in any particular.

8. We believe that the saints will persevere in grace and never finally fall away.

9. We believe that Baptism, the Lord's Supper and the washing of Saints' feet are ordinances of Jesus Christ and that only true believers are subject to these ordinances and that the only true mode of baptism is by immersion.

10. We believe that the punishment of the wicked shall be everlasting, and the joys of the righteous shall be eternal.

11. We believe that no minister has the right to administer the ordinance of Baptism and the Lord's Supper who has not been regularly called and come under the imposition of the hand of the Presbytery.

12. We believe in the resurrection of the dead and a general judgment.
