President's Message

With this issue of *The Southeastern Librarian*, we inaugurate a new approach to our award-winning journal. As determined by the Executive Board, *The Southeastern Librarian* will continue to be a communication vehicle for members of the Southeastern Library Association and to conduct Association business. It will report on library news, trends, and developments in the region. And the journal will continue to represent a significant means for addressing the research objective of the Association through the publication of articles and research results. The journal will remain quarterly.

The changes initiated with this volume include a new format and content approach. The journal will now concentrate its focus in two issues of news, association business and various informational notices and reports. It is hoped that the two news issues will assist in making communications with members more timely.

The other two issues will focus on significant research and articles addressing trends, developments, and issues related to library and information access and services. In order to strengthen the research prestige of *The Southeastern Librarian*, it has been recommended that the journal move to having the research issues juried.

To accomplish the new approach for the publication, we have a new Editor and staff. Debra Sears, Chief of the Bureau of Library and Network Services at the State Library of Florida has assumed the editorship. Lawrence Webster, College Center for Library Automation, Tallahassee, FL and Marie Landry of Baton Rouge, LA, currently in the Ph.D. program at Florida State University, are assistant editors. Their willingness to take on this important task is greatly appreciated. I hope that all members will give them their full support and contribute to making *The Southeastern Librarian* informative, vital, and useful.

An Editorial Board is being formed to provide guidance to our Editor and Assistant Editors and to develop the juried research portion of the publication program. Theresa Johnson, former Editor of the journal, has agreed to chair the Editorial Board.

It is exciting to have *The Southeastern Librarian* in an attractive new format and being published on its regular schedule. Thank you all for bearing with us as we went through the transition of the journal to its new approach. Please communicate with the editors as to what you would like to have published and what is useful to you. Your

contributions of articles, news, and other information are most welcome.

I want to take this opportunity to remind you that the Conference Committee is hard at work on plans for the thirty-eighth biennial conference in Little Rock, Arkansas. The dates for, "Southern Libraries: Diamonds of Information", are September 30 - October 3, 1998. Please mark your calendar now for this opportunity to learn, meet old friends and make new ones, and enjoy this unique part of our region. I visited Little Rock in December and feel this site provides an outstanding venue for our conference. Since this is a joint conference with the Arkansas Library Association, we will have the benefit of many knowledgeable local people in planning and organizing the programs and social events. The conference will utilize the Excelsior Hotel, which is connected by a stairway off its lobby, to the convention center. One need not even go out of doors to reach conference programs and exhibits. However, the hotel occupies a beautiful waterfront location, and offers convenient access to a number of interesting and fun sites along the river and in downtown Little Rock. So staying inside during the entire conference would not allow one to fully appreciate all this conference has to offer!

Southeastern Library Association leadership are meeting in Atlanta in late March to continue work on transition efforts. The Executive Board, committees, state association representatives, and SELA members will continue to develop plans for operational changes and new approaches to insure that SELA remains vital and important in the region. Stateside News

Alabama

In partnership with the **Alabama Public Library Service**, the **Gates Library Foundation** is bringing computers and the Internet to more than 200 libraries statewide. The Foundation is providing grants, technical assistance and training worth between \$2.5 million to \$3 million.

While the core of the Foundation's gift are direct grants for public access to computers and Internet service, six new computer training centers at libraries in Birmingham, Mobile, Demopolis, Montgomery, Tuscaloosa and Huntsville will be funded as well. Implementation began in December 1997 and continues through mid-1998.



Florida

Broward County Library won a \$600,000 Challenge Grant from the National Endowment for the Humanities. The grant will be used to support construction of the African-American Research Library and Cultural Center, acquisition of the humanities collections, and an endowment for future humanities programming. The African-American Research Library and Cultural Center will contain over 75,000 books, documents, and non-print materials by and about African-Americans and related topics and will open in late 1999.



The Distance Learning Library Initiative, a cooperative effort of public universities, community colleges and public libraries to support Florida's emerging distance education programs, is well under way. The electronic resources component includes access to Britannica Online and the full complement of OCLC FirstSearch databases. A Distance Learning Reference and Referral Center has been established at the University of South Florida's library (Tampa), and a pilot document delivery program is under development. Georgia

Michael L. Lomax, Ph.D., president of Dillard University, New Orleans, and **Margaret Walker**, retired state library consultant, were named the

inaugural recipients of the **Annie L. McPheeters Medallions** by the Atlanta-Fulton Public Library's Auburn Avenue Research Library on African-American Culture and History. The Annie L. McPheeters Medallion honors "unsung heroes and heroines" who have worked toward the improvement of race relations and have contributed substantially to the understanding and interpretation of the African-American experience in the Southeast and throughout the nation.



SOLINET received a grant for \$551,768 from the U.S. Department of Commerce, through the community-wide networking initiative of the Telecommunications and Information Infrastructure Assistance Program (TIIAP) in the National Telecommunications and Information Administration. SOLINET will use the grant to fund a 25-month project to improve access to electronic public information by applying consensus-based standards to support information sharing in five Southeastern communities. These communities are Tallahassee (Leon County), Florida; Fort Lauderdale, Florida (through the Southeastern Florida Library Information Network); Madison (Morgan County), Georgia; Greensboro, NC and Memphis/Shelby County, TN. 2. News releases, newsletters, clippings, and journals from libraries, state associations, and groups throughout the region may be used as sources of information.

4. Manuscripts should be submitted in duplicate on plain white paper measuring 8½" x 11." Manuscripts should be 8-10 pages double-spaced, including text and references. Computer disks will be requested on publishing notification. Please contact the Editor for further information.
5. The name, position, and professional address of the author should appear in the bottom left-hand corner of a separate title page.
6. Authors should use the author-date system of documentation. The editors will refer to the latest edition of *The Chicago Manual of Style*. The basic form for the reference within the text is as follows: (Hempel 1990, 24) The basic form for articles and books in the reference list is as follows: Hempel, Ruth. 1990. "Nice Librarians Do!" *American Libraries* 21 (January): 24-25. Senn, James A. 1984. *Analysis of Information Systems*. New York: McGraw-Hill.
7. Photographs will be accepted for consideration but cannot be returned.
8. *The Southeastern Librarian* is not copyrighted. Copyright rests with the author. Upon receipt, a manuscript is acknowledged by the Editor. Following review of a manuscript, a decision is communicated to the writer. A definite publication date is given before publication. Publication can be expected within twelve months.

Stateside News

North Carolina

A recent gift from **Baker & Taylor** will enable a student at the **University of North Carolina at Chapel Hill's School of Information and Library Science** to attend a two-week seminar at Oxford University, England. The seminar, "Libraries and Librarianship: Past, Present and Future", is co-sponsored by the school and Oxford's continuing education department. Begun in 1992, the seminar is open to all library and information science professionals and graduate students and includes lectures and tours of Oxford and the Bodleian Library. In January 1998 the **North Carolina State University Libraries** opened its **Scholarly Communication Center**, the first such enterprise in the country. Peggy E. Hoon, Scholarly Communication Librarian, will offer guidance to NC State librarians and to faculty, students, and staff on university policy relating to the dissemination and use of published knowledge. Formerly Copyright Specialist at Washington State University, Hoon will represent the interests of NC State at the national level. The Center seeks to help shape national policies relating to scholarly communication to ensure that scholars, students and libraries retain the full benefits of legal protection under copyright and fair use in the digital environment.



South Carolina

The **South Caroliniana Library** at the **University of South Carolina, Columbia**, has been awarded \$69,353 by the National Historical Publications and Records Commission. The grant will be used to increase access to fifteen previously unprocessed manuscript collections that document the emerging American South. The 18-month project encompasses processing, creation of MARC records, production of collection inventories which will be available via the Internet, and rehousing of collections to archival standards.

Record units include papers of attorneys and South Carolina legislators B.L. Abney and James H. Hammond, writer Elizabeth Boatwright Carter, agriculturist Robert R. Coker, entrepreneur James L.

Coker, artist Blondelle Malone, newspaperman Sam Latimer, Georgetown mayor W.D. Morgan, and records of the Christian Action Council, a statewide ecumenical, interracial church agency.



Tennessee

The **Tennessee Newspaper Project's searchable database** of information about newspapers held in Tennessee institutions is now available on the web. Holdings information was collected through a statewide survey which began in 1994. While the Tennessee Newspaper Project staff continue to catalog the newspapers in OCLC, the Tennessee Newspaper Project database is the most comprehensive resource for locating American newspapers held in Tennessee libraries. Virginia

The **University of Virginia Library** has placed thousands of historic photographs of Charlottesville and Albemarle County and of turn-of-the-century white and African-American residents on the World Wide Web. The pictures are from the library's Holsinger Studio Collection, a unique photographic record of life in Charlottesville and the surrounding area from the late 19th century into the 1920s.

Approximately two-thirds of the images are studio portraits of local residents and families. There are also many scenes from community and University of Virginia events. One of the most historic Holsinger photos is a portrait of artist Georgia O'Keefe, who lived for a time on Wertland Avenue and taught art at the University of Virginia early in her career.

Retirements

Barbara Williams Jenkins retired as Dean, Library and Information Services at the Miller F. Whittaker Library at South Carolina State University on June 30, 1997. During her forty-year career at SCSU she served

as Circulation and Reserve Librarian, Reference and Documents Librarian, and Dean. Dr. Jenkins was one of several African American pioneer librarians to integrate the South Carolina Library Association and eventually served as the SCLA's first African American President. She has also served on the ALA Council, as Secretary and Vice Chairman of the SOLINET Board of Directors, and as President of the Black Caucus of ALA.

Marvin W. Mounce, Library Program Specialist with the Florida Division of Library and Information Services, retired on August 31, 1997. During his 40-year career Mounce held positions as technical services coordinator, state library consultant, public library director, chief of library development for Pennsylvania, and library educator.

Jean Rhein, Director of the Seminole County Library System, FL for 19 years, retired on December 19, 1997.

Frank Rogers, Director of Libraries at University of Miami, retired in August 1997 after 18 years with the university.



Deaths

Lester Asheim, William Rand Kenan, Jr. Professor at the School of Information and Library Science at the University of North Carolina at Chapel Hill, died on July 1, 1997. Asheim was a member of the faculty at the Graduate Library School of the University of Chicago, 1948-61 and 1971-74, and served as dean from 1952-1961. He served as director of ALA's International Relations Office from 1961-1971 and as director of the ALA Office for Library Education from 1966-71. Asheim's article, "Not Censorship but Selection" (Wilson Library Bulletin 28: 63-7 Sept. 1953) is considered by many to be his most important work. Asheim received numerous honors and awards, including the Joseph W. Lippincott Award, University of Washington's Distinguished Alumnus Award, Illinois Library Association's Intellectual Freedom Award, and the Beta Phi Mu Award for Distinguished Service to Education for Librarianship.

Betty Callahan, former director of the South Carolina State Library, died February 7, 1998. She joined the library in 1960 and served as adult consultant, director of field services and deputy director prior to becoming director from 1979-1990. She initiated the South Carolina Library Network and was instrumental in

securing state funding to allow public libraries to participate electronically in resource sharing.

Lynda Carlberg, Director of the Calcasieu Parish Library System, LA died on November 17, 1997 following an automobile accident. She was president of the Louisiana State Board of Library Examiners and past president of the Louisiana Library Association.

Frederic J. Glazer, former Executive Secretary of the West Virginia Library Commission, died on December 9, 1997. Under his guidance, West Virginia became the first state to have a statewide borrower's card. He initiated a statewide construction program which more than tripled the number of major library buildings and aggressively pursued state and national monies to enhance library services. For 17 years he cosponsored the annual Library Skills Institute with Marshall University to provide training for library personnel. Glazer was the recipient of numerous awards and honors, including the first Columbia University School of Library Service Distinguished Alumni Award (1987).

Helen Deloise Lockhart died on October 21, 1997 at her home in Memphis. She directed the Memphis/Shelby County Public Library's community relations program and later served as the library's Friends of the Library Liaison and Volunteer Coordinator. She was a member of the Board of Directors of the Friends of the Library USA.; served as president of the Tennessee Library Association in 1967-68; served as president of SELA from 1978-80; and was Tennessee's representative on the ALA Council from 1972-1976.

Gary Purcell, professor emeritus and former director of the School of Information Sciences, University of Tennessee Knoxville, died on May 6, 1997. He retired after 24 years with the school but continued to contribute by serving as a member of the advisory board. Purcell was past president of the Reference and Users Services Association (RUSA), a division of the American Library Association, the Association of Library and Information Science Education (ALISE), and the Tennessee Library Association. In 1994 he was awarded honorary membership in SELA.

Dr. Ruth H. Rockwood, Professor Emeritus of the School of Information Studies, Florida State University, died July 5, 1997 in Tallahassee, Florida. In 1952-53, she had served as a Fulbright Lecturer in library science at Chulalongkorn University, Thailand. An active contributor to developing library services, she taught at Florida State University for 26 years, from 1953 through 1979.

CCAHA Continues Subsidized Overview Survey Program

The Conservation Center for Art and Historic Artifacts' (CCAHA) preservation overview survey program has been extended through April 2000 through continued funding from the National Endowment for the Humanities (NEH). The survey process, offered at a reduced rate through this program, has three stages: a general evaluation of an institution's preservation needs (environment, housekeeping, pest control, fire protection, security and disaster preparedness; collection storage, handling, exhibition and treatment; and preservation planning); a site visit which includes a review of the site, examination of collections and staff interviews; and a written report to serve as guide in the development of a comprehensive preservation plan for paper-based collections.
