2001 SELA Leadership Conference a Big Success

The 2001 SELA Leadership Conference, held April 6th in Atlanta, was highly successful with 96 paid attendees. SELA president Barry Baker opened the conference with a "State of the Association" address, followed by addresses from Charles Beard, Library Director at State University of West Georgia and Kate Nevins, Executive Director of SOLINET. The remaining morning agenda consisted of committee break out sessions, followed in the afternoon by reports from each committee, section, and roundtable. Members enjoyed a bountiful buffet lunch.

"State of the Association" -- Barry Baker

In his kickoff address Mr. Baker welcomed SELA members to Atlanta, thanked everyone for attending, and reiterated SELA's goals for 1998-2002 as stated in the strategic plan:

1. Increase membership in SELA
2. Promote cooperation and communication among SELA libraries and librarians
3. Provide quality continuing education and staff development opportunities for its membership
4. Promote a regional identification and culture
5. Raise sufficient financial support to perform its mission and serve as an advocate for adequate funding for libraries in the southeast

He identified keys to success in achieving these goals:

Get Involved!: There are many opportunities for SELA members to participate in governance of the organization. Several sections and roundtables have openings for officer positions including: Public Libraries section, Library Education section, Reference and Adult Services section, School and Children's Libraries section, Special Libraries Section, Government Documents Round Table and the Paraprofessional Round Table.

Try New Ideas: Be creative. We want to offer professional development and leadership training opportunities for our members to enable them to better meet the challenges facing libraries in this

rapidly changing environment. We need new programs and new projects to accomplish this.

Improve communication among members:

Every member will soon be subscribed to the new SELA listserv. Use this to inform members of your section, roundtable or committee activities.

Be a part of the success of our journal: *The*

Southeastern Librarian is resuming a regular publication schedule. There are opportunities for participation by submitting articles or by serving on review and editorial boards. For additional information contact Frank Allen, editor, at fallen@mail.ucf.edu.

Mr. Baker encouraged those in attendance to review the 1998-2002 Strategic Plan and consider ways to promote these goals. He reiterated the success of the 2000 joint conference with the Georgia Council of Media Organizations at Jekyll Island in October, 2000. Past, Present and Future -- Charles Beard

Mr. Beard gave a brief history of SELA, beginning with its founding in 1920 when a group of 100 librarians from 10 southern states met in Signal Mountain, Tennessee in an effort to improve library conditions throughout the South. Those founding librarians represented Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, and Virginia. With the intent of nurturing cooperation, resource-sharing and professional friendships at a time when many states within the southeast were suffering severe economic times and could do little to assist their libraries, SELA quickly came to life. Over the decades SELA grew in numbers and prosperity, becoming itself a reflection of the evolving South. SELA sponsored the Southeastern States Library Cooperative Survey beginning in 1946-47. *The Southeastern Librarian* began publication in 1951 and soon began receiving awards for the quality of the publication. In 1972 and 1978 SELA co-sponsored two joint conferences with the Southwestern Library Association. West Virginia

joined SELA in 1973 and was followed by Arkansas in 1980.

The decade of the 1970's was SELA's "golden age." Membership reached a high point in 1974 with 3,611 dues paying members. The Tennessee Valley Authority (TVA) provided a \$100,000 grant in 1976 to assist SELA in development and long range planning efforts for all libraries in the region.

During the 1980's and 1990's SELA continued to accept and deal with new challenges. The fact that SELA was so successful in establishing library cooperation and resource-sharing through the South made it imperative for the organization to continue to establish new goals and accept new roles that would lead to improved library services. Mr. Beard identified several areas that he felt SELA might choose to adopt toward this "end": advocacy for underrepresented groups; implementing a comprehensive training program to develop management and interpersonal skills for library staffs; furthering literacy efforts; continuing to play a social and networking role among library professionals; and career enhancement among library paraprofessionals. He challenged those in attendance to think "outside the box," to focus SELA's resources on solving library problems within the region and through member planning, hard work and energy, to move SELA ahead into a new century with renewed vigor and commitment.

Kate Nevins Issues Call to Arms

Today, I would like to issue a call to arms to all of us, the SELA Leadership. SELA is an organization with a noble history and an uncertain future. SELA has contributed to the development of cooperative programming throughout the southeast, helped develop productive and innovative library professionals, and brought generations of librarians together for networking, programming and action.

However, in recent years, some members have questioned the continued need for SELA. They point out that the focus of much cooperative activity has shifted to states and regional organizations such as SOLINET, that technology supports library interaction and cooperation in ways that do not require meetings and

associations, and travel to meetings outside the region is easier and cheaper than years ago. In this environment, is SELA still necessary?

As a long-time SELA member, I answer that question with a resounding "yes." But this will only be with the commitment of the SELA membership to make it so. I challenge the SELA leadership and membership to:

1. Articulate the mission and purpose of SELA in a way that is meaningful to the regions' libraries. The emphasis could include cross-state cooperation, mentoring of new librarians, and building relationships. Broad based discussions could help articulate SELA's mission for today's libraries.
2. Translate the mission and purpose into goals and actions. We must ask, "What is the Association, through each committee, task force or program doing to support the mission?" It must be seen that SELA will actively work to support the needs of its members.
3. Reach out to the library profession in the region. We need to enfranchise more libraries and paraprofessionals in the association. Outreach to those who are not members and opportunities to participate actively in the association are ways to make SELA strong.

In closing, I would like to suggest several areas where SELA can make a very real contribution to the state of our profession.

First, strengthen the next generation of library professionals. This includes recruiting people into the profession, mentoring new librarians, and providing opportunities to develop a range of skills. Second, issues of intellectual property rights and the legislative agenda will have a profound impact on librarians in the near future. SELA provides an excellent forum for regional action and support. Third, SELA should consider the major continuing education needs of library staff as technology, policy and library programs evolve.

It's a busy agenda. Let's get started!!

University and College Library Section

The SELA Leadership Conference this past April in Atlanta was an exciting and active event. The UCL Section met under the guidance of Chair, Diane N. Baird, Middle Tennessee State University, and amidst all the activity planned their contribution for the 2002 SELA/SCLA Conference in Charleston, SC.

Two programs are now being planned. UCLS will sponsor a repeat of the popular "New Voices" program that was so successful at the 2000 Conference. The mission of "New Voices" is to offer professional development opportunities for librarians with less than five years' professional experience. A call for papers will go out several months before the conference. A review panel from across the region will judge submissions and select two papers to be presented at the session. The second program being planned by UCLS is a joint effort with the South Carolina Library Association. This program will be based on the use of technology for library instruction, particularly Web courseware such as WebCT and Blackboard.

The UCLS is pleased to be working on two such important programs for the SELA membership; one that will encourage the growth and development of new professionals and one that will provide insight into a current trend in library instruction. See you all in Charleston.

In addition to having the SELA display set up at state conferences, it was also suggested that a state conference activity for SELA members be planned. Other leading suggestions include a membership survey; networking/cooperating with other groups such as the Association for Library and Information Science Education (ALISE) and ALA; taking advantage of all opportunities to inform others about SELA (i.e. new employee orientations, one on one, and speaking with students who will soon be librarians), a job placement center at SELA conferences; and a link to the SELA web page from each state association web page.

Stateside News

Alabama

"Real librarians, real experiences and real actions" best describes the 2001 Alabama Library Association's convention April 10-13 in Montgomery and reflects why the theme "Alabama Libraries Build Communities" was chosen. The keynote speaker Lorraine Johnson-Coleman, African-American folklorist and author of *Just Plain Folks* and *Larissa's Breadbook*, connected with her audience, as she shared stories about her family and community in the rural South. Seth Hammett, speaker of the Alabama House of Representatives, received the Public Service Award for promoting the Alabama Virtual Library (AVL). His vision of "equity, economy and excellence for Alabama citizens and students" was instrumental in obtaining the funding for the AVL and its more than 50 databases. The Eminent Librarian Award was presented to Dr. Shirley Spears, director, B.B. Comer Memorial Library, Sylacauga, Alabama. B.B. Comer is one of only four libraries in the nation to receive a 2000 National Award for Library Service from The Institute of Museum and Library Services. This award honors institutions which "demonstrate the power of libraries as the cornerstones of community life." Sandra Nelson, national consultant, speaker, trainer and writer, caught the attention of Alabama public library board members as she explained their roles as community and library leaders. Karen Hyman, nationally known speaker and writer, spoke about the 21st century library and the twelve strategies for a "connected world." Dr. Jane B. Robbins, dean of the Florida State University School of Information Studies, presented "Information Literacy." A tour of the Rosa Parks Library and Museum, Montgomery, Alabama, served to reinforce the continued importance of building communities.

The Gala Reception sponsored by Gale in honor of Rebecca Buckner Mitchell, president of the Alabama Library Association, provided a collegial atmosphere to enjoy successes with one another. The following additional awards were made: *Merit Award* to the Mountain Brook Library Foundation *Distinguished Service Award* to Dr. Janice Franklin of Alabama State University Library; *Humanitarian Award* to Danny Stewart of Pell City Public Library; *Alabama Library Roll*

of Honor to Harold Katz, board member of the Guntersville Public Library from 1965 to 2000.

The Alabama Library Association recognized its authors with the 2001 *Author Award* for Fiction given to Sena Jeter Naslund; the *Non-Fiction Award* given to Homer H. Hickam; and the *Juvenile/Young Adult* award given to Han Nolan. Jaunita Owes, director of the Montgomery City-County Library, chaired the convention.



In other Alabama Library Association Convention ceremonies, the Birmingham Public Library was recognized for excellence in library service. The Association and the Alabama Public Library Association honored the library for achievement of the *Blue Ribbon Level* of Alabama Public Library Standards. *Blue Ribbon Level* achievement signifies that the Birmingham Public Library has met or exceeded the seventy-one criteria that constitute an outstanding public library.



The Birmingham Public Library has joined up with Hand-in-Paw, an animal-assisted therapy organization, to announce a pioneering new *Sit, Stay, READ* literacy program with a "pawsitive" theme. *Sit, Stay, READ* was designed to help reluctant readers improve their skills in an innovative way – with help from a special group of four-legged animals. This summer these programs took place at the Avondale Regional Branch Library and the North Avondale Branch Library of the Birmingham Public Library System. Hand-in-Paw's certified handler and animal teams served as literacy mentors for children identified by specialists as reluctant readers. Conducted in branch libraries near schools, *Sit, Stay, READ* creates a non-threatening learning environment that helps youngsters focus on possibilities rather than limitations by eliminating the embarrassment of many group-reading situations. It's a program shown to improve children's literacy skill in an effective manner. The program also helps reduce the child's fear of animals and builds confidence and trust between the child and the animal.

The Alabama Library Association is celebrating its Centennial with a five-year fundraising drive, culminating in 2004 with its 100th anniversary. The Association welcomes your support in making a tax-deductible gift to the Centennial Campaign. Arkansas

The Arkansas State Library and the Arkansas Library Association have joined together in a statewide public relations campaign, incorporating the ALA "@ your library™" logo. The \$200,000 campaign, funded by the State Library with LSTA funds, kicked off in October 2000.

During National Library Week, the campaign placed advertisements in all Arkansas newspapers and sponsored an online trivia contest with a major radio company with several stations. The campaign theme, "Information. Recreation. Inspiration" is based on the Melvil Dewey quote: "A librarian's function is to give the public in the quickest and cheapest way information, inspiration, and recreation."

The public relations committee of the state association is working with a graphics designer to create materials that can be used for several years. Posters, bookmarks, calendars, brochures, and a custom trade show exhibit featuring the new campaign graphics will be introduced at the association's annual conference, Oct. 21-22, in Little Rock. The campaign is also placing a year's worth of nonprofit service announcements on the state's three public radio stations.

Florida

The design and construction contract for Jacksonville's \$150 million library construction/renovation program has been awarded to Heery International of Atlanta. The centerpiece of the work will be a new 300,000 square foot main library downtown, estimated to cost \$95 million. The balance of the funds will go

toward construction of six new libraries and renovation of six other libraries in the city. The downtown library is expected to be completed mid-2003.



Ruth and Jack Eckerd (founder of the Eckerd Drug chain) have provided a \$2 million challenge grant to kick off a capital campaign for the new Greater Clearwater main library. The new 90,000 square foot library has a total project cost of \$20.2 million and is expected to be completed by September, 2003. Robert A. Stern, renowned architect and Dean of the Yale University School of Architecture has been named the design architect. Funding authorities hope to raise \$5 million in private donations for the project.

Georgia

Pullen Library celebrated the scholarly and creative achievements of Georgia State University faculty on April 17, 2001, in the House Salon of the Student Center. University President Carl Patton and University Librarian Charlene Hurt welcomed the GSU community and other guests to the exhibit and reception in honor of faculty authors whose works were published during 2000. In their remarks both Dr. Patton and Ms. Hurt congratulated the faculty on their scholarship, creativity and productivity. This year's exhibit of the work of faculty authors featured not only monographs but other formats as well, including periodical articles, compact discs, book chapters and musical scores. A printed bibliography of 1,082 entries of publications with an imprint of 2000 and authored by GSU faculty members was compiled and presented to them. On June 4 & 5, 2001, 220 University System of Georgia librarians and library staff members convened in Athens at the University of Georgia for the annual GIL Users Group Conference. "GIL" is an acronym for GALILEO Interconnected Libraries, the second phase of the highly successful GALILEO initiative. GIL is an online catalog and library management system for USG libraries that links every collection in the University System. GIL uses Endeavor Information System's Voyager software. Since the summer of 1998, Endeavor staff members and USG library staff members have been working to migrate USG library catalogs to Voyager. The final USG library catalog went "live" on May 18, 2001, a milestone that enables the University System of Georgia to have a web-based online union catalog of the six million books in the USG library collections. Attendees at this year's conference celebrated GIL's achievements with cake and punch to commemorate the occasion (see photo). The Thomas B. Murphy Holocaust Center, located in Ingram Library at the State University of West Georgia, was officially dedicated on June 21, 2001. The mission of the Center is to train teachers in methods of developing tolerance and promoting cultural understanding in the classroom by providing workshops and seminars and by acting as a clearinghouse for research materials. Dr. Richard Voyles is the director of the Center.



Through the collaborative efforts of the directors of the three regional Georgia libraries, Vera J. Weisskopf (GSW's James Earl Carter Library), Jane B. Hendrix (Lake Blackshear Regional Library), and Jerry Stovall (South Georgia Technical College's Library) and their library staffs, a wide-ranging cooperative agreement was developed and officially went into effect January 1, 2001. The purpose of the agreement is to provide optimal access to information resources and services for the students and citizens of Sumter, Crisp, Dooly, and Schley counties, GA.



Dr. Harold Isaacs, Professor of History & Political Science at Georgia Southwestern State University, has donated his extensive collection of Third World Studies materials to the James Earl Carter Library. The Ellins, ivy-league educated teachers from New York City, came to Hattiesburg, Mississippi, in 1964 to work in the Freedom Schools established as a part of the Mississippi Freedom Summer Project. The letters describe the Ellins' daily activities and concerns as civil rights workers, their relationships with local black citizens, and their attempts to promote grass roots support for civil rights among their friends and relatives back home. The posters from the Ellin collection are public relations publications of the Student Nonviolent Coordinating Committee (SNCC). North Carolina

With the Internet changing faster than you can click a mouse, a few years can be a long time for a Web site to go without a facelift. So the Public Library of Charlotte & Mecklenburg County (PLCMC) decided it was time to redesign its six-year-old site – not merely for cosmetic improvement, but as a more efficient way for millions of on-line patrons to use the library's web services. On Aug. 1, 2001 the site <http://www.plcmc.org/> – debuted with its new look.

Helene Blowers, Director of Web Services at PLCMC, whose team accomplished the redesign, listed these enhancements to the new PLCMC site:

- New and improved site index, making it easier for web users to locate specific areas of interest.
- New "For Kids" and "For Teens" sections that highlight homework help resources,

reading and book resources, and fun sites to visit.

- Expanded offerings of online resource and research tools (bringing the total to more than 50), including the newly added "New Book of Knowledge," "Lands & People Online" and "New Book of Popular Science."
- The "History of PLCMC" in streaming video format.
- Easier access to the PLCMC online catalog and enhanced help screens for accessing information on renewing books online, viewing a patron's record and placing a book on hold.
- A "Beyond Books" section that showcases library services far beyond its book collections.

In 1995, PLCMC became one of the first public libraries in the U.S. with its own Web site. Today, in addition to its main information site (www.plcmc.org) the library has developed and maintains nine specialty sites offering Web users everything from children's reading suggestions and book reviews (at www.bookhive.org) to consumer health information (at www.healthlinkplus.org) and local history archives (www.cmstory.org).



The long-awaited presentation of the new Children's Learning Center design took place June 25th at the Public Library of Charlotte & Mecklenburg County before an audience of more than 100 people, including young people who had provided ideas for the facility. As part of the occasion, Kenneth D. Lewis, chairman & chief executive officer of Bank of America Corp., announced that the CLC will be named for Charlotte civic leaders Joan and Joseph B. Martin III. The 107,000-square-foot Children's Learning Center (CLC) is a partnership between the Library and Children's Theatre of Charlotte. When completed in 2004, the CLC will be an integral part of Charlotte's burgeoning cultural district, which already includes the Main Library, Museum of the New South, Afro-American Cultural Center, Blumenthal Performing Arts Center, Mint Museum of Craft + Design, Tryon Center for Visual Art and Spirit Square. The

Center will be constructed using \$27 million that Mecklenburg County voters approved in 1999. In addition, a private, \$12 million endowment campaign is underway to help fund CLC programming.

The Center features library facilities, including an early childhood education center, juvenile collection and teen center; performance facilities, including 550-seat and 250-seat theaters; a storytelling venue, blue-screen production studio, exhibit halls, classrooms and art studios, a gift shop, a meeting room and administrative and theater support spaces. In addition, a large, multi-story public space contains interactive exhibits and serves as a gathering area and reception venue.



The North Carolina Library Association (NCLA) will host a job placement center at the NCLA Biennial Conference in Winston Salem, October 3-4, 2001. South Carolina

Proceeds from the University of South Carolina Music Library's Dorothy K. Payne Endowment were used this year to purchase 58 ozalid scores by the Italian composer Mario Castelnuovo-Tedesco (1895-1968). All of the scores are inscribed by the composer. Thirty-two of the items are "Greeting Card" scores which are short pieces for various instruments based on the name of an individual, usually a composer or performer. Castelnuovo-Tedesco relocated to the United States from his native Florence in 1939 and became well known as a composer of orchestral, dramatic, chamber, and film music. Among his students were Henry Mancini, Andre Previn, and John Williams. The new collection of Castelnuovo-Tedesco scores was featured at a reception honoring Dr. Payne, professor and former dean of the USC School of Music, held at the Music Library on June 21. At that time, music librarian, Jennifer Ottervik announced that the new items, combined with materials already in the

library, have formed the largest Castelnuovo-Tedesco collection in the world.



USC's South Carolina Library has received a major addition to its Carlisle Floyd Collection. Comprising one of the library's most significant twentieth-century collections, these materials document the life and works of Carlisle Floyd, the Latta native who has come to be considered one of the few masters of American opera. His musical drama, *Susannah*, is regarded as the most enduring work yet written by an American for the lyric stage.

Floyd presently resides in Tallahassee, Florida, following a twenty-four-year residency as the M. D. Anderson Professor in the School of Music at the University of Houston and co-director of the Houston Opera Studio.

The new materials include 2.5 linear feet of libretti, stage bills, reviews, letters, and photographs which detail the performance of his works nationally and internationally for almost half a century. Of special interest is material relating to the production of his revision of *The Passion of Jonathan Wade*, an opera that is set in Columbia, South Carolina, and of his most recent work, *Cold Sassy Tree*.



The University of South Carolina's Thomas Cooper Library has received a major collection of materials pertaining to American novelist and poet, Ernest Hemingway. The collection was acquired through donations from the family of Maurice Speiser (1880-1948) of Philadelphia and from Edward Hallman of Atlanta, a 1950 graduate of the University. Mr. Speiser, who was Hemingway's friend and legal advisor for many years, amassed the collection and left it to his son, Raymond, who continued to add appropriate items.

The collection, which is appraised at \$1.7 million, includes numerous first editions of Hemingway's works, as well as typescripts, issues and articles from newspapers and magazines, and correspondence between Maurice Speiser and many 1920s writers and artists. Among these are, besides Hemingway, William Faulkner, Lillian Hellman, D.H. Lawrence, Henry Miller, Carson McCullers, Ezra Pound, John Steinbeck, Leonard

Bernstein, Aaron Copeland, George and Ira Gershwin, Gian-Carlo Menotti, Eugene Ormandy, Serge Prokofieff, Paul Robeson, Arnold Schoenberg, Leopold Stokowski, Igor Stravinsky, Marc Chagall, and Constatin Brancusi. An exhibit of materials from the collection will be mounted in the fall.
