# International Relations Club Convention Held Here At The University Of Georgia

Kirk McAlpin, Savannah, law student of the International Relations Club of Georgia, was elected the first president of the International Relations Club of Georgia, a statewide collegiate group organized in Athens Saturday.

Vice president of the University of Georgia IRC, McAlpin was chosen to head the new state organization by acclamation of the seven colleges and universities represented at the meeting.

Other officers elected were Frank Lastra, Tampa Fla., Georgia Tech, vice president; Betty Hayes, Milledgeville, Georgia State College for Women, secretary-treasurer; and Emmet E. Noland Jr., Athens, University of Georgia, corresponding secretary.

Institutions represented in the formation of the organization were Bessie Tift College, Brenau College, Emory University, the Georgia School of Technology, the Georgia State College for Women, Wesleyan College, and the University of Georgia. The largest out-of-town representation was from G.S.C.W., which sent a delegation of 10.

Ralph Williams, Crawfordville, president of the host club, presided over the luncheon meeting at the N & N Cafeteria and the afternoon business session in the Commerce-Journalism Building.

## Luncheon Speakers

Speakers at the luncheon included Anne Wells, Milledgeville, a member of the G.S.C.W. delegation, who discussed "The Importance of Student Opinion on International Affairs." She characterized student opinion as "a Niagara of potential power" in helping to formulate and guide public opinion regarding world affairs.

Describing what a student should get from a college education Miss Wells asserted that the student has the right to expect his college to give him a heritage from the past; to teach him universal truths rather than trivial things; and to make him aware of what is going on in the world today. She called for "a Renaissance spirit—ever looking for the truth."

McAlpin reported on the visit made by him and Marion L. Bridges, Sumner, to the United Nations Security Council in New York last summer. He told of meeting students from many other colleges and universities and of attending U. N. sessions which featured debates by delegates

Gromyko of Russia, Evatt of Australia, Cadogan of England, and Johnson of the United States.

Admitting that weaknesses exist in the present U. N. Charter, McAlpin urged that students study that document. He asked them to have faith in the U. N., to help improve it, and to help build up mutual trust among nations.

William Tate, dean of students, welcomed the convention delegates to Athens and commended them on their serious attitude toward world problems.

Other University of Georgia officials attending the session were Dr. E. Merton Coulter, head of the history department, who founded the local IRC; Dean S. Walter Martin of Coordinate Campus; J. Chal Vinson, history instructor and IRC faculty adviser; and Mrs. Vinson.

Accompanying delegations of students from their respective institutions were Dr. Helen I. Greene of G. S. C. W. and Prof. James W. Moffitt of Bessie Tift College.

Primary business of the afternoon was the adoption of a constitution for the new organization. The document adopted states that:

## Purpose Of Club

"The purpose of this club shall be to support discussion of world affairs from an unprejudiced and objective point of view, but not to support exclusively any one view as to how it would be best to treat the conditions which prevail throughout the world.

"It shall further be our purpose to exert mutual effort to fix the attention of all members on those underlying principles of international conduct, of international law and of international organization which must be agreed upon and put into action if a peaceful civilization is to continue."

Mary A. McCravey, law student at the University of Georgia, introduced the draft from which the constitution was adopted, and presented a series of proposed resolutions which are to be studied by the individual clubs and voted on at the next meeting.

The cabinet of the state organization voted to accept the invitation of Emory, Tech, and Agnes Scott to hold the next annual convention in Atlanta during the winter quarter of 1948.

Chairman of arrangements for the Athens convention was Oscar

CONSTITUTION OF  
GEORGIA INTERNATIONAL RELATIONS CLUB

--

Preamble

We, the students of the International Relations Clubs of the various colleges in the State of Georgia, acting as an organization under the auspices of the Carnegie Endowment for the purpose of discussing world affairs, hereby adopt the following constitution:

ARTICLE I - Name

This organization shall be known as the Georgia International Relations Club, in accordance with the internationally accepted designation for organizations sponsored by the Carnegie Endowment for International Peace.

ARTICLE II - Purpose

The purpose of this club shall be to support discussion of world affairs from an unprejudiced and objective point of view, but not to support exclusively any one view as to how it would be best to treat the conditions which prevail throughout the world. It shall further be our purpose to exert mutual effort to fix the attention of all members on those underlying principles of international conduct, of international law, and of international organization which must be agreed upon and put into action if a peaceful civilization is to continue.

ARTICLE III - Officers

Section 1 -

A President, Vice-President, a Secretary-Treasurer, and a Corresponding Secretary shall be elected at each annual meeting of the Club, as hereinafter provided, and shall serve for the subsequent year.

Section 2 -

Said officers shall be elected by the student representatives in attendance at the annual meeting of the Club. The representatives from each college shall cast one vote for each officer, and the person receiving a majority of said votes shall be elected.

## ARTICLE IV - General Government

### Section 1 - Duties of Officers

In addition to performing the generally accepted duties of the office which they hold, the officers of the Club shall serve as a cabinet or directive group for the Club.

### Section 2 - Membership

- A. Any International Relations Club that is active on any of the college campuses throughout the State of Georgia shall be admitted to membership in the Georgia International Relations Club provided a written declaration of such intent is filed with the Secretary-Treasurer of said Club.
- B. Any college not sending representatives to the annual meeting of said Club shall be dropped from membership, provided an acceptable excuse is not filed with the Secretary-Treasurer of said Club within 15 days after the annual meeting.

### Section 3 - Meetings

A meeting of this organization shall be held during the winter quarter of each year, at a time and place designated by the Cabinet of said organization.

### Section 4 - Assessments

The annual assessments will be made by the council at its discretion.

### Section 5 - Revision

Amendments to this constitution or revision thereof may be accomplished at any time by securing the vote of approval of two-thirds of the colleges in attendance at any annual meeting of said Club.
