My dear Chancellor:

I have your note of this morning stating that there is no rush about the matter of the Home Economics department.

I have felt all year that we could finance this department without difficulty. I had thought that about \$5000.00 ought to be budgeted for it, \$4200.00 of which should be for salaries of two teachers, one in cookery and dietetics and the other in textiles and dressmaking, sewing, etc. The remainder of \$800.00 could be used for equipment during the year, and very little would be required for supplies during the first year.

In transmitting one of his quarterly budgets to me, Mr. Dusenbury adds a little note to this effect: "The quarterly budget request for the fourth quarter, being filed today, contemplates a carry-over into the year 1934-35 of the sum of \$7716.51. While this request is trimmed down close, it is possible that by July 1st this sum will aggregate \$8000.00. Of this amount, the sum of \$4000.00 was entered as revenue on the budget and distributed in the expenses thereof for the year 1934-35." But that would still leave nearly \$4000.00, and we anticipate that during the coming year, if things go as they seem to promise, we shall probably lay up \$2500.00 as a carry-over.

The only thing in the way, it seems to me now, is our application for \$35000.00 from the C. W. A., whose business seems to have been handed over to the F. E. R. A. Fifteen percent of the amount asked for would have to be paid for by us, and that would just about consume the amount I had calculated upon to set the home economics department afloat. However, I am not very sure that this request to the F. E. R. A. will be granted, and if it is granted, it may be granted on impossible terms.

Page 2.

I have heard from some source that money furnished by the Federal Government may be spent only for labor and not for materials. If that be true, we would have to withdraw our request because the school could not meet these terms. My belief is that our request will fall through, and if it does, it seems to me the way to the introduction of a home economics department is wide open. I would suggest that nothing be done about the matter until we have an answer from the authorities of the F. E. R. A.

I thank you for your kindly references to the syllabi furnished by these teachers, and will take a great deal of pleasure in transmitting your praise to them.


My dear Dr. Pound:

Upon motion of Regent Smith, seconded by Regent Dunwody and unanimously approved, amendments appearing in Minutes of the meeting of this Board held February 17, 1934, viz., Section #18 of the By-Laws - DUTIES OF THE CHAIRMAN: Section #45: DUTIES OF THE CHANCELLOR were adopted unanimously. Same are as follows:

Section 18: DUTIES OF THE CHAIRMAN

The Chairman shall preside at all meetings of this Board, appoint the members of its standing committees and ex-officio serve as a member of same.

The Chairman of the Board, upon its authority and in its name, shall execute all notes, bonds, deeds, conveyances, contracts and any other writings requiring the seal of the Regents of the University System of Georgia.

In addition to the foregoing he shall exercise general supervision over the Chancellor and Secretary-Treasurer in the performance of their duties.

Section 45: DUTIES OF THE CHANCELLOR

(a) Relation of the Chancellor to the Board of Regents: The Chancellor shall be the chief executive officer of the University System and, as such, shall perform all of those duties that are prescribed by the Board of Regents. He shall be responsible to the Board of Regents for the prompt and effective execution of all the rules and regulations adopted by the Board for the ordering of the entire University System and for the government of any and all of its branches.

The Chancellor shall have the right and it should be his duty to attend and to participate in (without the privilege of voting) all of the meetings of the Board of Regents and of its committees. He shall make all nominations and recommendations for appointments, promotions, salaries, transfers, suspensions, dismissals, and all recommendations for the appointment of

administrative officers, members of instructional and scientific staffs, and all other employees of the several institutions and services of the University System.

(b) Relation of the Chancellor to the University System: The Chancellor shall be a member of all faculties and other academic bodies having legislative authority within the University System. He shall decide all questions of jurisdiction, not otherwise specifically defined, of the several councils, faculties, and officers. He shall have the right to refer any question of institutional concern or of University System policy to any council, faculty, committee, or member of the institutional, scientific, extension or administrative staffs for investigation and report. He shall have the right to call meetings of any council, faculty, or committee at any time.

(c) Veto Power of the Chancellor: The Chancellor shall have the power to veto any act of any council, faculty, or committee within the University System, but in so doing he shall transmit to the proper officer a written statement of the reason for such veto. A copy of each veto statement shall be transmitted to the Board of Regents. Any council, faculty or committee shall have the right to appeal from a veto of the Chancellor to the Board of Regents and to be represented before the Board by any member or members chosen for that purpose from said council, faculty, or committee.

(d) Reports and Budgets: The Chancellor shall prepare and submit to the Board of Regents such annual and special reports concerning the University System as the Board may require. He shall also be responsible for the preparation and presentation to the Board of the annual budget of the University System and such other financial reports as may be necessary.

Upon motion of Regent Smith, seconded by Regent Dunwoody, and upon vote of the ten members present, it was ordered that the word "Chairman" in the last paragraph of Section #20 of the By-Laws of this Board be changed to "Chancellor"; said changed by-law as thus amended reading as follows:

SECRETARY

20. The Secretary of this Board shall not be a member thereof, but shall be present at all meetings of Regents of the University System of Georgia and shall keep an accurate record of the proceedings at such meetings in books provided for that purpose, and shall perform such other duties and have such other powers as Regents of the University System of Georgia shall from time to time designate.

The salary of the Secretary shall be fixed by the Board, and be payable twice a month, on the 15th and the last day of each calendar month. He shall give good and sufficient bond, payable to the Governor of this State, for the faithful performance of his duties and for the faithful accounting of all funds coming into his hands in such amount as may be fixed by the Finance Committee. The surety on said bond shall be a surety company qualified to do business in the State of Georgia. The said Regents of the University System of Georgia shall pay out of funds coming into their hands the premiums for said bond.

In the absence of the Secretary from any meeting, a secretary pro tempore shall be chosen, who shall record the proceedings of the meetings on books kept for the purpose.

The Secretary shall give, or cause to be given, notices of all meetings of Regents of the University System of Georgia; he shall keep in safe custody the seal of the corporation, and when authorized by Regents of the University System of Georgia, affix the seal to any instrument requiring it, and when so affixed it shall be attested by his signature; he shall be sworn to faithfully discharge his duties as Secretary.

He shall keep the minutes and records of all meetings of Regents of the University System of Georgia; he shall be the custodian of all deeds, muniments of title to all of the property embraced in the University System of Georgia; he shall also be the custodian of all trust funds of all Institutions under control of Regents of the University System of Georgia; all the money and securities of every kind and character belonging to the various trust funds shall be in his custody and under his control; and he shall keep a strict and separate account of each fund, showing the securities in each fund, cash on hand, and a detail of all of the income and disbursements; he shall make itemized reports, along with his recommendations as to sales and investments, or reinvestments of all trust funds, at each quarterly meeting of the said Regents, and shall keep Regents of the University System of Georgia thoroughly posted as to all of the matters being handled by the Secretary; he shall be under the immediate supervision and control of the Chancellor of the University System of Georgia. It shall be his duty to answer promptly all communications addressed to him or Regents of the University System of Georgia, which have reference to the matters under his control, and shall refer all communications and letters relating to matters not handled by him to the proper authority.

It is ordered by this Board that the Executive Order presently in effect exempting, from the payment of fees, the children of professors, in attendance upon units within the University System, is hereby revoked, effective as of July 1, 1934.

WHEREAS, it is impossible to perfect lists of personnel at the various units in time for this meeting; the same be prepared by the Chancellor as expeditiously as possible and that he be given authority to act on the nominations of such personnel as may have been sent in by the heads of the units in the University System and to pass on each of the constituted budgets, provided the separate allotments are not exceeded.


