Dear Frank:

I am enclosing a description on one page of all the land owned by your father, consisting of four lots in Peardale, five acres in one tract and an adjoining tract of one acre.

On the second page I have listed the three deeds made by your father from this land. I think the deed to Laura and E.D. Mathis covers the four lots in Peardale but I am not sure.

The other two deeds seem to be triangular in shape or else one side has been left off in the description. The one to Idella Bell conveys about one-fourth acre and the one to Richard Mobbley one-half acre.

It seems that your father's estate owns about five acres in lot 365 at the present time.

If you are selling all this to one person you can make a deed describing the whole of the property listed on first page and follow the description with the words:
"Except the following described lands heretofore sold by John Goseer", and insert the description of the three parts sold as shown on second page.

If you intend to divide it up it will be necessary to have a surveyor make a plat of it.
